UPON hearing the counsel the Court made the following O R D E R

#### IA No 143717 of 2022

- 1 Following the resignation of four directors, the strength of the Board of Directors appointed by the Union Government has come down to four.
- 2 The IA has been moved by the Union Government for filling up the vacancies.
- 3 Presently, the Union Government is permitted to appoint Ms Uma Shankar, former Executive Director, Reserve Bank of India on the government appointed Board of Unitech Limited.

- 4 IA is accordingly disposed of.
- 5 Liberty to the Union Government to move this Court afresh for filling up the remaining vacancies.

# Issue of refunds to FD holders and Home buyers of the age group 65-75 years and above 75 years

6 In his report dated 8 October 2022, Justice Abhay Manohar Sapre has classified the FD holders and Home buyers into three separate lists which are as follows:

"List - A	Cases where the Medical Professionals were of the view that these cases did not qualify to be treated as cases of Medical Exigencies.
List - B	Cases where the supporting documents were examined and the cases were found to be eligible under Medical Exigencies.
List - C	Cases where the applicants had not submitted/ uploaded any documents in support of their Medical Conditions."

7 Those persons who fall within List A were given a further opportunity of presenting their submissions on a virtual platform. Ultimately, Justice Sapre has recommended as follows:

- 8 A list of 220 Home buyers who have been recommended for full refund has been annexed at Annexure 12 of the Report.
- 9 The recommendation is accepted.
- 10 The disbursal of the amount of Rs 83.80 crores to 220 Home buyers shall be subject to the following conditions:
  - (a) The full refund once made by the company to eligible Home buyers on the

ground of medical exigency be considered as being so made "in full and final satisfaction of their claims";

- (b) There shall be only full refund of principal amount and no claim of interest on principal amount would henceforth survive and they shall have no claim of any nature against the Unitech Group in future;
- Apartment/Units/Plots etc. which were allotted to them against their deposits shall henceforth form a part of the unsold inventory of Unitech Group;
- (d) The refund of the principal amount would be made after deducting the amount of service tax which has been deposited by the company with the Government; and
- (e) In those cases where the home buyers have taken loans from banks or financial institutions, the disbursal shall be made directly to the concerned banks/financial institutions, upon which the lien on the units which have been sold shall stand released. Any balance that remains after satisfying the claim of the banks/financial institutions shall be paid over to the home buyers.
- 11 To facilitate the disbursal of an amount of Rs 83.80 crores to the Home buyers, the following directions are, in addition, issued:
  - The Registry of this Court shall, within two weeks, disburse an amount of Rs 83.80 crores out of the amount which is lying in deposit by electronic transfer to the authorized account of Unitech Limited operated by the Government appointed Board of Management;
  - (ii) The details of the bank account of Unitech Limited and all required details

for facilitating disbursal shall be made available to the Registry within a period of one week; and

- (iii) The Government appointed Board of Management of Unitech Limited shall disburse the amounts to Home buyers as directed in the recommendations submitted by Justice Abhay Manohar Sapre, upon the submission of advance receipts together with the surrender of all documents and upon due verification of identity. The disbursal shall be made by the Board of Management within a period of one month from the date of the receipt of funds from the Registry of this Court.
- 12 The Court will consider the issue of the disbursal of the amounts recommended in the Report of Justice Abhay Manohar Sapre to fixed deposit holders on account of medical emergencies on the next date of listing.
