UNDERTAKING FOR DECLASSIFICATION

With regard to our request for declassification as a promoter of Stampede Capital Limited (referred to as, the "Company") and in accordance with Regulation 3I A of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, We confirm and undertake the followings:
