Sub: Appeal filed in NCLAT – Updates regarding hearing on November 30, 2022 and December 02, 2022

Ref: Disclosure under Reg 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015

Pursuant to Regulation 30 of SEBI (LODR) Regulations, we wish to inform that an appeal was filed before the National Company Law Appellate Tribunal (“NCLAT”) against the order of Hon’ble National Company Law Tribunal, Hyderabad (“NCLT”) dated 27.04.2022 initiating the CIRP process of Vanta Bioscience Limited.

The matter was listed on 30.11.2022 and the matter in the said hearing was further adjourned to 02.12.2022. In the hearing on 02.12.2022, the Bench heard both the sides and noted that the hearing is completed in full and the judgement is reserved. The Counsels appearing for the respective parties are permitted to file their ‘Notes of Submissions’ before the “Office of the Registry” with in three working days. The Learned Counsels appearing for the respective parties are required to submit the ‘Memo of Calculation’, in respect of the ‘Amounts’, claimed (Attaching upon the ‘Plea of Threshold Limit’, as per Section ‘4’ of the Insolvency & Bankruptcy Code, 2016), for the purpose of this ‘Tribunal’, within ‘Three Working Days’ from ‘Today’, before the ‘Office of the Registry’ (on both Modes), and to serve a copy of the same to the other side, well in advance. The Learned Counsel for the ‘2nd Respondent’ / ‘Interim Resolution Professional’ is permitted to file ‘Status Report’ before the ‘Office of the Registry’ (on both ‘Modes’), within ‘Three Working Days’, from ‘Today’, and to serve a copy of the same to the other side, well in advance.
