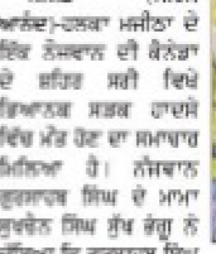

TO PLAN RETALIATION TO IRAN'S ATTACK

Israeli War Cabinet to Meet for 3rd Time Amid Restraint Calls

US working overtime with world powers for sanctions on Iran to prevent escalation

Jerusalem: Israel's war cabinet was set to meet for the third time in three days on Tuesday, an official said, to decide on a response to Iran's first-ever direct attack, amid international pressure to avoid further escalating the conflicts in the Middle East. Military chief of staff Herzl Halevi had promised that Saturday night's launch of more than 300 missiles, cruise missiles and drones from Iran into Israeli territory "will be met with response", but gave no details.

While the attack caused no deaths and little damage, thanks to the air defences and countermeasures of Israel and its allies, it has increased concerns that violence rooted in the Gaza war is spreading, and fears of open war between the long-time foes. Iran launched the attack in retaliation for an airstrike on its embassy compound in Damascus on April 1 attributed to Israel, but signalled that it did not seek further escalation.

President Joe Biden told Israeli Prime Minister Benjamin Netanyahu at the weekend that the United States, Israel's main protector, would not participate in an Israeli counter-strike. Together with European allies, Washington instead strove on Tuesday to toughen economic and political sanctions in an attempt to persuade Israel to abstain from violent retaliation. Israeli foreign minister Israel Katz

said he was "leading a diplomatic attack", writing to 32 countries to ask them to place sanctions on Iran's missile programme and follow Washington in proscribing its dominant military force, the Revolutionary Guard Corps, as a terrorist group.

European Union (EU) foreign ministers scheduled a video meeting on the Middle East for Tuesday. Last autumn, Germany campaigned with France and other EU partners to extend an existing EU sanctions regime against Iran that targets drone pro-

duction. Its foreign minister, Annalena Baerbock, said on Tuesday that several EU members had now promised to look again at extending those sanctions, announcing that she would head to Israel within hours to discuss how to prevent an escalation.

British Prime Minister Rishi Sunak said on Monday that the Group of Seven major democracies was working on a package of measures against Iran, Italy, which has the G7 presidency, suggested any new sanctions would target individuals.

Will Use Sanctions to Disrupt Iran's Malign Activity, Says Yellen

Washington: US treasury secretary Janet Yellen on Tuesday said Iran's attack on Israel last weekend and its financing of militant groups in Gaza, Lebanon, Yemen and Iraq threatened stability in the Middle East and could cause economic spillovers. Yellen began remarks prepared for a news conference by addressing what she called an unprecedented attack on Israel by Iran and its proxies, saying Treasury would use its sanctions authority and work with allies to "continue disrupting the Iranian regime's malign and destabilizing activity." **Reuters**

With Yuan's Help, US Dollar Bulldozes its Way Through EM Currencies

The resurgent dollar cut a swath through global emerging-market currencies Tuesday, weakening many through closely watched levels that forced some officials to step in to stem the losses.

China's move to weaken its daily reference rate for the yuan added to the selling pressure, with the Indonesian rupiah, Indian rupee and the South Korean won among the hardest hit. But the dollar impact was broader, with a global gauge of emerging market currencies falling to fresh lows for the year. Stocks also extended their losses, with a benchmark of emerging-market equities erasing their gains for the year.

The dollar's strength forced Bank Indonesia to step in to support the rupiah after the currency weakened past 16,000 per dol-



lar for the first time in four years, as onshore markets reopen after a holiday that was more than a week long. South Korea's foreign-exchange authorities warned of the risk of excessive one-sided currency moves on the economy after the won dropped to the closely watched level of 1,400 per dollar for the first time since

CHINA LOOSENS GRIP ON YUAN

"Pressure on EM currencies could last until we get clarity on the Fed's plans," said Rajeev De Melo, a global macro portfolio manager at GAMA Asset Management. "While the medium-term positive trend is intact, the market will go through turmoil before regaining a better footing."

Attention will turn to Europe where currencies like South African rand, Polish zloty, Israeli shekel are facing pressure.

"Most EM currencies will have to capitulate to the strength of the dollar," said Mitul Kotecha, head of FX and EM macro strategy at Asia at Barclays. "In Asia, weakness in the yen and the weaker China yuan fixing add another layer of pressure." **Bloomberg**

Swift on Taylor Deepfakes: Meta Oversight Board Reviews Policies

Meta Platforms's Oversight Board is investigating the company's handling of AI-generated deepfakes of an "American public figure," following a surge of such images depicting singer Taylor Swift earlier this year.



The board will evaluate whether two separate AI-created images depicting "nude" women posted on Facebook should have been removed under Meta's content policies, according to a statement Tuesday. The organisation, which is funded by Meta but designed to be independent, reviews content decisions made on Facebook and Instagram. Sexually explicit deepfake images of Swift began flooding Facebook, Instagram, X and other social media platforms in January, prompting outcry from the White House. Luxe Apartments Sell Like Hot Cakes in NCR

New Delhi: Delhi-NCR has the highest proportion of luxury apartments priced at ₹15,000 per square foot and above among the top eight cities, reflecting a trend where buyers are gravitating towards premium residences, with most high-end projects selling out within days of their launch.

According to data by Cushman & Wakefield, 61% of the total apartments launched in Q1 FY 2024 in the NCR were high-end luxury, while Mumbai had only 26% of apartments launched in this segment, followed by Bengaluru at 19%. However, all the cities have witnessed an increase in this segment post Covid-19, with developers focusing on luxury projects. The share of luxury houses moved to 38% in 2024 from 6% in 2019 in Ahmedabad, 11% to 19% in Bengaluru, 9% to 28% in Chennai, and 42% to 63% in Hyderabad.

US, China in Tesla's Job Cuts List

Shanghai | Berlin: Tesla's global job cuts include reducing staff in the US and China, the automakers' two biggest markets, across sales, tech, and engineering, five sources briefed on the matter said. CEO Elon Musk on Monday told staff in an internal memo seen by Reuters that the company is laying off more than 10% of its global workforce, as it grapples with falling sales and an intensifying price war for electric vehicles. Several US-based service centres saw heavy layoffs effective immediately, primarily of sales staff and technicians, one source said. Another location laid off all front-of-house staff, the source said. A Tesla programme manager in California posted a spreadsheet on LinkedIn of over 140 staff, mostly engineers, who had been laid off and were seeking new jobs.

Two sources said members of Tesla's China sales team were being notified they were being made redundant, with one saying more than 10% were losing their jobs. **Reuters**
