Sub: Adoption of IND-AS for the first time from the financial year 2019-20 and Extension of time for the submission of financial results for the quarter ended June 30, 2019.

As per Regulation 33 of SEBI (Listing Obligation and Disclosure Requirements) Regulation, 2019, the Company is required to submit its quarterly financial results to the Stock Exchange within 45 days from the end of the quarter.
