Nitesh Rane surrenders, sent in police custody in attempt to murder case

MUMBAI, FEB 2 --/ BJP MLA Nitesh Rane on Wednesday surrendered before a court in the Sindhudurg district of Maharashtra in an alleged attempt to murder case and was remanded in police custody till February 4, his lawyers said.

Nitesh, son of Union minister Narayan Rane, had withdrawn his bail plea from the Bombay High Court earlier in the day. He subsequently surrendered before the Sindhudurg court, said special public prosecutor Pradip Gharat. The prosecution then sought his police remand. District and additional sessions judge (Sindhudurg) R B Rote had on Tuesday rejected Rane's bail application, saying it was "premature and not maintainable". The court had also held that custodial interrogation of Nitesh Rane was necessary as probe into the attempt to murder case was "incomplete." The case pertains to an alleged attack on Shiv Sena activist Santosh Parab during the campaigning for the Sindhudurg district cooperative Bank elections. The BJP MLA had claimed that he was being targeted by the ruling Shiv Sena (which heads the MVA coalition government in Maharashtra) as it felt slighted by an incident of mocking outside the state legislature complex here last December. It was political vendetta, he had alleged.

A Shiv Sena MLA had alleged that Nitesh Rane made 'meow meow' sound to mock minister and Sena leader Aaditya Thackeray

wants to join the investigation. This is despite the fact that the applicant still has five more days of protection from arrest granted to him by the Supreme Court on January 27, Maneshinde said. Justice Bhadang then allowed the withdrawal. Nitesh Rane's pre-arrest bail pleas had been rejected by both the lower court and the HC earlier. The MLA then approached the supreme court, which on January 27 asked Maharashtra Police not to arrest him for ten days, and directed him to appear before the court in Sindhudurg and seek regular bail. ED arrests Maharashtra businessman in fraudulent FSI linked money laundering case

NEW DELHI, FEB 2 --/ The Enforcement Directorate (ED) on Wednesday arrested Maharashtra-based businessman Pravin Raut in a money laundering case linked to alleged irregularities in the sale of FSI of a plot by a firm, linked to him, that is a subsidiary company of the housing development infrastructure Ltd.

HDIL is under investigation by the ED and few other agencies in connection with the about Rs 4,300 crore alleged fraud at the Punjab and Maharashtra cooperative (PMC) Bank. Official sources said the ED arrested Raut following his questioning at its office in Mumbai. The agency had carried out

searches at some premises linked to him in Maharashtra on Tuesday. He was arrested under the provisions of the Prevention of Money Laundering Act (PMLA). The ED probe found that a company, identified as Guruashish construction, was given a contract by the Maharashtra housing and area development authority (MHADA) to re-develop a 'chawl' in suburban Mumbai and some alleged irregularities were found related to the sale of the floor space index (FSI) of this project. Guruashish construction is linked to Pravin Raut. The agency last year had attached Rs 72 crore worth assets of Raut in the PMC Bank money laundering case. It had then said that "probe revealed that Rs 95 crore has been siphoned off through HDIL by one of the accused Pravin Raut in active conspiracy and connivance with various persons." "The source of the funds were illegal availed loans/ advances by HDIL from PMC Bank. There was no document or agreement in support of these payments made to Pravin Raut," the ED had alleged in a statement. It said "as per the ledger of HDIL, the funds were given to Pravin Raut for acquiring land in Palghar area."

The agency had also questioned Shiv Sena MP Sanjay Raut's wife Varsha Raut last year in connection with the PMC Bank case and her purported links with the Pravin Raut's wife. It had said that Pravin Raut "paid an amount of Rs 1.6 crore to his wife Madhuri Pravin Raut from the proceeds of crime. Out of the said money, Madhuri Raut transferred Rs 55 lakh (Rs 50L on December 23, 2010 and Rs 5L on March 15, 2011) as interest free loan to Varsha Raut, who is the wife of Sanjay Raut."

"The amount was further utilised for purchase of flat in Dadar East, Mumbai," the ED had said. It had also said that Pravin Raut and Madhuri Pravin Raut "are partners in Avani Construction and Varsha Raut has received Rs 12 lakh from this

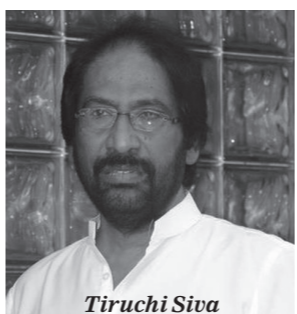
entity (as overdrawn capital converted to loan) on a contribution of mere Rs 5,625.

"The ED had filed a criminal case of money laundering in October, 2020 to probe the alleged loan fraud in the PMC Bank and had booked HDIL, its promoters Rakesh Kumar Wadhawan, his son Sarang Wadhawan, its former chairman Waryam Singh arden-managing director Joy Thomas.

It took cognisance of a Mumbai Police economic offences wing FIR against them that charged them for causing "wrongful loss, prima facie to the tune of Rs 4,355 crore to PMC Bank, and corresponding gains to themselves". (PTI)

Centre transgressing rights of states: DMK MP Tiruchi Siva

NEW DELHI, FEB 2 --/ The Centre is transgressing the states' rights and impinging on the federal structure of the country, DMK MP Tiruchi Siva alleged on Tuesday in the Rajya Sabha.

Taking part in a debate on the motion of thanks on the President's address, he also accused the government of favouring the rich at the cost of the poor. Citing the example of amendment of the All India Services cadre rules, which gives the Centre the power to call civil servants to its services without the consent of states, he said, "...this is again transgressing the rights of the states". "This is a federal country. Did you consult any of the states? No... This is not an indication of federalism," Siva asserted. He alleged that after the BJP assumed power, "democracy is in peril, secularism is at stake, federalism is (being) targeted, states' rights encroached and transgressed" and the minorities are "unsafe".

The DMK MP further alleged that the Centre's actions and its policies are aimed at "tapping the poor and patting the rich". "People pay taxes to the government. The government, instead of addressing the very core issues, the crumbling MSME sector, impact of Covid-19, increase in (prices of) the essential commodities... instead of addressing all these issues you are prioritising to fight off minorities' rights, values and beliefs," he said. 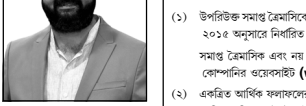
