## ROCEEDINGS OF THE 29<sup>TH</sup> ANNUAL GENERAL MEETING OF TELESYS INFO-INFRA (I) LIMITED

The 29<sup>TH</sup> Annual General Meeting ("AGM") of the Members of Telesys Info-Infra (I) Limited (the "Company") was held on 30<sup>th</sup> day of September, 2021, through Video Conferencing (VC)/ Other Audio Visual Means (OAVM). The said AGM commenced at 03:00 pm (IST) and concluded at 03:15 pm (IST).

Mr. Heerachand Jain- Director of the Company chaired the Meeting and welcomed the Members of the Company.

With the requisite quorum being present, the Chairman called the meeting to order and welcomed the Shareholders to the Company's 29<sup>th</sup> AGM. The Chairman informed that the Meeting was held through VC/ OAVM in compliance with the circulars issued by the Ministry of Corporate Affairs, Government of India and Securities and Exchange Board of India and the AGM Notice and Annual Report for the financial year 2020-21 had been sent electronically to those members whose email ids were registered with the Company/RTA or Depository Participants.

The Company Secretary informed that the facility for remote e-voting commenced at 9:00 A.M. on Monday, September 27,2021 and concluded at 5:00 P.M. on Wednesday, September 29,2021. He also informed that voting by electronic means was also available during the AGM to those shareholders who had not already voted by means of remote e-voting. He also stated that as the 29<sup>th</sup> AGM is being held electronically, the facility of appointing proxy was not applicable. He further informed the Shareholders that Mr. Amarendra Mohapatra, a Practicing Company Secretary, was appointed as the scrutinizer to scrutinize the voting through electronic means (i.e. remote e-voting and voting at the meeting by using electronic system) in a fair and transparent manner and that he was present at the meeting through video-conferencing means.

Thereafter, the Notice convening the 29<sup>th</sup> AGM of the Company was taken as read by the Chairman, with the consent of the Members present. Further, the Chairman informed that there were no qualification(s), observation(s) or adverse remark(s) of the Statutory Auditors or the Secretarial Auditors in their Report(s) for the financial year ended March 31, 2021 and the same were taken as read.
