My responsibility as a scrutinizer is to ensure that the voting process both through remote E-voting/E-voting at Annual General Meeting as well as Physical Voting is conducted in a fair and transparent manner and to provide a consolidated Scrutinizer's Report of the votes cast "In favor" or "Against" the resolutions contained in the Notice to the chairperson of the meeting or his authorized representative, based on the reports generated from system of Central Depository Services (India) Limited (CDSL), the service provider.

The Notice convening Annual General Meeting dated 05th September, 2023 was sent to the Shareholders through electronic means to those shareholders whose e-mail address were registered with the Company / depositories.

Voting rights were reckoned as on 22nd September, 2023, being the cut-off date for the purpose of deciding the entitlements of members for remote e-voting /e-voting at the AGM and Physical Voting. The voting period for remote e-voting commenced on 27th September, 2023 at 09.00 A.M. (IST) and concluded on, 29th September, 2023, at 5.00 p.m. (IST) and thereafter the CDSL e-voting platform was blocked and then re-opened during the Annual General Meeting.

At the 50th Annual General Meeting convened through Physical Presences, it was announced that the members who have not exercised their voting right through E-voting and are attending the meeting, if they wish they can exercise their right to vote through E-voting and physical voting facility provided by the Company during the meeting.

After the conclusion of the Annual General Meeting the votes cast by the members through remote e voting as well as E-voting and physical voting at Annual General Meeting was unblocked in presence of two witnesses who are not in the employment of the Company.
