# Familiarise with newer global areas: FM to CAs

New Delhi, 17 August

'nion Finance Minister Nirmala Sitharaman on Thursday asked chartered accountants (CAs) to familiarise themselves with global developments, such as carbon accounting, to better advise clients.

She also asked the CAs to use digitisation as an opportunity to build public trust in companies.

"India and its new economy is being driven by startups and industry, which is transitioning to new ways of doing things... It requires hand-holding your clients. This will happen only if you are on top of technology yourself," Sitharaman said at the national CA conference in Bhubaneswar.

The finance minister said the Institute of Chartered Accountants of India (ICAI) might want to set up newer standards, best practices, and template for others to follow for each of the newer global areas. These include carbon accounting, corporate social responsibility accounting, and auditing along with due diligence related to environment, social, and gov-

ernance (ESG) norms.

"Now due diligence is required by your clients for even negotiating for the transfer of technology for funds and negotiating with partnerships...The new course (by ICAI), which has been planned

is of critical relevance," Sitharaman said.

Praising the transparency brought by digitisation, Sitharaman said it had helped in building trust not just between the company and its bookkeeper but also among the public.

On the use of technology and generative artificial intelligence, Sitharaman said: "The traditional image of accounting as a manual and tedious process is rapidly evolving; and for your good."

She said the ICAI had also played an important role in the smooth roll-out of the goods and service tax and made a difference in widening the tax base.

The FM said ICAI's new course was very much in line with the national education policy (NEP). "The focus is more on how to learn rather than what to learn. The NEP gives the creative instinct to learning. It is not about what to think but how to think... How will it matter more when you have to advise your clients," she added.

Sitharaman also advised the ICAI to leverage its memoranda of understanding with various countries and strive for

Party makes first move in MP, Chhattisgarh, releases list of candidates before EC's election dates

New Delhi, 17 August

The Bharatiya Janata Party (BJP) on Thursday announced 21 of 90 candidates for the Chhattisgarh Assembly and 39 of 230 for Madhya Pradesh, focusing on declaring candidates on seats reserved for scheduled tribes (STs). In 2018, the BJP performed poorly on the seats reserved for STs in these two states.

In a rare move, the BJP released its first list of candidates even before the Election Commission (EC) declares the dates for the Assembly polls, which could help its candidates prepare better.

The BJP's lists came a day after Prime Minister Narendra Modi chaired the party's election committee meeting.

Five states — Madhya Chhattisgarh, Pradesh, Rajasthan, Mizoram, and Telangana — will vote to elect fresh Assemblies in November-December. In 2018, the EC announced the poll dates in the first week of October. Of the 21 candidates the BJP

**PERFORMED** announced for Chhattisgarh. **POORLY IN 2018** four are women, nine on seats reserved for STs and one for Scheduled Castes (SCs). In Madhya Pradesh, of the 39, five candidates are women, eight announced on SC reserved

seats, and 13 on seats reserved for STs.

In Madhya Pradesh, 47 seats are reserved for STs and 35 for SCs. In Chhattisgarh, 29 are reserved for STs and 10 for SCs. In Chhattisgarh, the BJP announced fielding Vijay Baghel, currently a Lok Sabha member from Durg, from the Patan Assembly seat. Baghel is a former legislator from Patan.

## Himachal death toll rises to 74

PRESS TRUST OF INDIA Shimla, 17 August

The death toll in rain-battered Himachal Pradesh rose to 74 as another body was pulled out of the rubble of a Shiva temple here and two more people killed in Chamba district. officials said on Thursday.

Twenty-one of these deaths were in the three major landslides in Shimla alone —at the Shiva temple in Summer Hill and in Fagli and Krishnanagar. Eight people are still feared buried in the temple debris.

On Wednesday, workers at the Summer Hill landslide site retrieved the body of P L Sharma, head of the Mathematics department at Himachal Pradesh University, Shimla Superintendent of Police Sanjeev Kumar Gandhi told PTI.

Two rain-related deaths were reported in Chamba district where a person fell from a height and another drowned, taking the death count over the past four days to 74, according to the state emergency operation centre.

The state recorded heavy rains for three days, beginning Sunday. After Tuesday, there has been less rain. There were light showers at some places on Thursday.

Since the onset of the monsoon on June 24, 217 persons have died in rainrelated incidents in Himachal Pradesh. Over the last three days, 2074 people have been evacuated from these areas.

#### Real-time flood updates

Amid a rise in flood-related incidents in the country, including loss of life and property, the government Thursday launched an app to disseminate real-time information on the flood situation in affected areas.

The FloodWatch app, will collect data from 338 stations to send real-time flood updates across 23 states and Union Territories, Central Water Commission Chairperson Kushvinder Vohra said. The app aims to use mobile phones to spread flood-related information and even provides forecasts for up to seven days, Vohra said while launching FloodWatch.

सेंसेक्स के दो तिहाई से ज्यादा शेयर गुरुवार को टूट गए। रिलायंस इंडस्ट्रीज में 1.2 फीसदी की गिरावट आई और उसने सेंसेक्स की गिरावट में सबसे ज्यादा योगदान किया। इसके बाद आईटीसी का स्थान रहा, जो 2.04 फीसदी ट्टा। विदेशी पोर्टफोलियो निवेशक

1,511 करोड़ रुपये के शुद्ध बिकवाल रहे, वहीं देसी संस्थागत निवेशक भी 314 करोड़ रुपये के शुद्ध बिकवाल रहे। एफपीआई की खरीदारी इस महीने सुस्त रही है। अगस्त में अब तक एफपीआई 9,381 करोड़ रुपये के शुद्ध खरीदार रहे हैं। बाजार में चढ़ने व गिरने वाले शेयरों का अनुपात मिलाजुला रहा और बीएसई पर 1,802 शेयर टूटे जबिक 1,784 में बढ़ोतरी दर्ज हुई।

एचडीएफसी सिक्योरिटीज के खुदरा शोध प्रमुख दीपक जसानी ने कहा, पिछले तीन दिनों में निफ्टी किनारे चला गया है और 19,317-19,326 के स्तर से समर्थन ले रहा है। हालांकि दिन में यह नकारात्मक बंद हुआ। 18,300 से नीचे जाने की संभावना दिख रही है। बढ़त पर इसे 19.483 पर प्रतिरोध का सामना करना पड सकता है।

## अदाणी समूह के शेयरों में उछाल

जीक्यूजी पार्टनर्स की तरफ से निवेश बढ़ाए जाने के कारण अदाणी समूह के शेयरों में गुरुवार को तेजी दर्ज हुई। बुधवार को अमेरिकी निवेश फर्म व अन्य निवेशकों ने अदाणी पावर की 8.1 फीसदी हिस्सेदारी 9,000 करोड़ रुपये में खरीदी थी, जिसे देसी बाजार में किसी एक खरीदार-विक्रेता का सबसे बड़ा ट्रेड माना जा रहा है। बाजार में कमजोरी के बावजूद अदाणी पोर्ट्स का शेयर 4.5 फीसदी चढ़ा जबकि अदाणी पावर में 2.6 फीसदी और मुख्य कंपनी अदाणी एंटरप्राइजेज में 1.5 फीसदी का इजाफा हुआ। समूह के 10 सूचीबद्ध शेयरों में सिर्फ तीन नकसान के साथ बंद हए। हिस्सेदारी की खरीद अदाणी समृह की प्रवर्तक इकाइयों वर्ल्डवाइड इमर्जिंग मार्केट होल्डिंग और एफ्रो एशिया ट्रेड ऐंड इन्वेस्टमेंट्स से हुई। जीक्यूजी पार्टनर्स की तरफ से ताजा निवेश कतर इन्वेस्टमेंट अथॉरिटी के निवेश के बाद हुआ है, जिसने अदाणी



ग्रीन एनर्जी में इस महीने 2.7 फीसदी हिस्सेदारी ली है। मार्च से अब तक जीक्युजी ने अदाणी समृह में 34.000 करोड रुपये (4.2 अरब डॉलर) का निवेश किया है। अदाणी प्रवर्तकों की तरफ से जुटाई गई रकम से समूह को अपना कर्ज घटाने और वृद्धि को रफ्तार देने में मदद मिलेगी। अदाणी-हिंडनबर्ग मामले में बाजार नियामक सेबी इस महीने अहम जांच रिपोर्ट जमा कराने वाला है।

# रक्षा कंपनियों के शेयरों की बढ़ रही चमक

रक्षा संबंधित कंपनियों के शेयर कैलेंडर वर्ष 2023 में शेयर बाजारों पर शानदार प्रदर्शन करने में कामयाब रहे हैं।

हिंदुस्तान एरोनॉटिक्स (एचएएल), भारत इलेक्ट्रॉनिक्स (बीईएल), भारत डायनामिक्स (बीडीएल), डेटा पैटर्न्स. एमटीएआर टेक, कोचीन शिपयार्ड और जीआरएसई के शेयरों में इस साल अब तक (16 अगस्त) 21 से 96 प्रतिशत के बीच तेजी आई है। तुलनात्मक तौर पर बीएसई का सेंसेक्स इस अवधि में करीब 8 प्रतिशत तक चढा है।

इन शेयरों में तेजी शानदार निर्यात अवसरों, मजबूत परियोजना प्रवाह और सरकार द्वारा स्थानीय निर्माण तथा रक्षा उपकरणों के स्वदेशीकरण को लगातार बढावा दिए जाने की वजह से दर्ज की गई है।

विश्लेषकों का कहना है कि हालांकि ऊंचे मूल्यांकन से जुड़ी यह संभव नहीं होगा। ऑर्डर बुक भी तेजी अल्पावधि में थम सकती है. क्योंकि कंपनियां हरेक तिमाही में मजबूत प्रदर्शन की निवेशकों की उम्मीदों पर खरी नहीं उतर सकती हैं। फिनट्रेक कैपिटल के संस्थापक अमित कुमार गुप्ता ने कहा, 'ऑर्डर बुक का मुल्यांकन तिमाही आधार पर नहीं किया जा सकता, क्योंकि यह 5-10 वर्षों की लंबी अवधि से जड़ी हुई है। चंकि कंपनियों ने बड़ी

दीर्घावधि परिदृश्य मजबूत

जहां रक्षा शेयरों के लिए मजबूत तेजी की राह को अल्पावधि में चुनौतियों का सामना करना पड़ संकता है, वहीं विश्लेषकों का मानना है कि इस क्षेत्र की विकास संभावनाएं मजबूत मांग (घरेलू और अंतरराष्ट्रीय बाजारों, दोनों में ) पर आधारित हैं। चुंकि घरेलु मांग मुख्य तौर पर सरकारी ऑर्डरों पर केंद्रित है, लेकिन इसकी निर्भरता का मतलब राजनीतिक और आर्थिक जोखिम भी है। फिस्डम रिसर्च द्वारा जारी एक ताजा रिपोर्ट में कहा गया है कि हालांकि बढ़ते निर्यात से इन चिंताओं की कुछ हद तक भरपाई हो सकती है।

#### कार्बन उत्सर्जन में कमी पर ओएनजीसी का १ लाख करोड़ रुपये निवेश

सार्वजनिक क्षेत्र की कंपनी के लक्ष्य में योगदान दे रही है। ओएनजीसी कम कार्बन उत्सर्जन वाली कंपनी बनने की दिशा में तेजी से कदम उठा रही है। इसके तहत वह नवीकरणीय और हरित हाइड्रोजन समेत पर्यावरण अनुकूल माने जाने वाले ऊर्जा क्षेत्र में इस दशक के अंत तक एक लाख करोड़ रुपये का

निवेश करेगी। कंपनी ने कहा कि उसने कम कार्बन उत्सर्जन वाले ऊर्जा क्षेत्र में विस्तार को लेकर विस्तृत रूपरेखा तैयार की है। ओएनजीसी ने बयान में कहा, 'कंपनी ने खुद को देश के महत्वाकांक्षी लक्ष्यों के साथ जोड़ा है और वह 2030 तक कार्बन उत्सर्जन में एक अरब टन की कटौती करने और कार्बन गहनता 45 फीसदी तक कम करने के देश

भारतीय सीमेंट विनिर्माताओं ने वित्त वर्ष 2022-23 के दौरान बिक्री प्रचार, विज्ञापन और बिक्री के अन्य खर्चों से संबंधित गतिविधियों पर 14 प्रतिशत अधिक खर्च किया है। कंपनियों की वार्षिक रिपोर्ट से यह जानकारी मिली है। वित्त वर्ष 23 में भारत की 13 सूचीबद्ध सीमेंट कंपनियों ने ऐसी गतिविधियों पर संयुक्त रूप से 3,076 करोड़ रुपये खर्च किए। इनमें से अल्ट्राटेक सीमेंट 1,296.09 करोड़ रुपये के साथ सबसे अधिक खर्च करने वाली कंपनी रही, जो एक साल पहले की तुलना में 16 प्रतिशत अधिक

# **Familiarise with newer** global areas: FM to CAs

New Delhi, 17 August

'nion Finance Minister Nirmala Sitharaman on Thursday asked chartered accountants (CAs) to familiarise themselves with global developments, such as carbon accounting, to better advise clients.

She also asked the CAs to use digitisation as an opportunity to build public trust in companies.

"India and its new economy is being driven by startups and industry, which is transitioning to new ways of doing things... It requires hand-holding your clients. This will happen only if you are on top of technology yourself," Sitharaman said at the national CA conference in Bhubaneswar.

The finance minister said the Institute of Chartered Accountants of India (ICAI) might want to set up newer standards, best practices, and template for others to follow for each of the newer global areas. These include carbon accounting, corporate social responsibility accounting, and auditing along with due diligence related to environment, social, and gov-

ernance (ESG) norms.

"Now due diligence is required by your clients for even negotiating for the transfer of technology for funds and negotiating with partnerships...The new course (by ICAI), which has been planned

is of critical relevance," Sitharaman said.

Praising the transparency brought by digitisation, Sitharaman said it had helped in building trust not just between the company and its bookkeeper but also among the public.

On the use of technology and generative artificial intelligence, Sitharaman said: "The traditional image of accounting as a manual and tedious process is rapidly evolving; and for your good."

She said the ICAI had also played an important role in the smooth roll-out of the goods and service tax and made a difference in widening the tax base.

The FM said ICAI's new course was very much in line with the national education policy (NEP). "The focus is more on how to learn rather than what to learn. The NEP gives the creative instinct to learning. It is not about what to think but how to think... How will it matter more when you have to advise your clients," she added.

Sitharaman also advised the ICAI to leverage its memoranda of understanding with various countries and strive for

The Bharatiya Janata Party (BJP) on Thursday announced 21 of 90 candidates for the Chhattisgarh Assembly and 39 of 230 for Madhya Pradesh, focusing on declaring candidates on seats reserved for scheduled tribes (STs). In 2018, the BJP performed poorly on the seats reserved for STs in these two states.

In a rare move, the BJP released its first list of candidates even before the Election Commission (EC) declares the dates for the Assembly polls, which could help its candidates prepare better.

The BJP's lists came a day after Prime Minister Narendra Modi chaired the party's election committee meeting.

Five states — Madhya Chhattisgarh, Pradesh, Rajasthan, Mizoram, and Telangana — will vote to elect fresh Assemblies in November-December. In 2018, the EC announced the poll dates in the first week of October. Of the 21 candidates the BJP

**PERFORMED** announced for Chhattisgarh. **POORLY IN 2018** four are women, nine on seats reserved for STs and one for Scheduled Castes (SCs). In Madhya Pradesh, of the 39, five candidates are

women, eight announced on SC reserved seats, and 13 on seats reserved for STs. In Madhya Pradesh, 47 seats are

reserved for STs and 35 for SCs. In Chhattisgarh, 29 are reserved for STs and 10 for SCs. In Chhattisgarh, the BJP announced fielding Vijay Baghel, currently a Lok Sabha member from Durg, from the Patan Assembly seat. Baghel is a former legislator from Patan.

from the Congress, has the BJP top brass worried. The party is expected to announce a third panel — an election campaign committee - for the state in thecoming weeks. When asked about Raje's non-inclusion in the poll panels, BJP state in-charge Arun Singh said she will campaign in the election. "She is the national vice president of the

party. She has a big role to play. She has been the chief minister of the state twice. She will campaign in the election. We all respect her," he told reporters.

#### Congress rejig

The Congress on Thursday appointed senior leader Mukul Wasnik as its general secretary in-charge for Gujarat. He replaced Raghu Sharma. The Congress performed abysmally in the Gujarat Assembly polls in December 2022.

In Madhya Pradesh, the Congress appointed Randeep Singh Surjewala as its general secretary in-charge, replacing Jai Prakash Agarwal. Surjewala is also the incharge of Karnataka, where the party scored a morale-boosting win in May.

The Congress appointed former legislator Ajai Rai as the party's Uttar Pradesh state unit chief, replacing Brijlal Khabri.

### Himachal death toll rises to 74

PRESS TRUST OF INDIA Shimla, 17 August

The death toll in rain-battered Himachal Pradesh rose to 74 as another body was pulled out of the rubble of a Shiva temple here and two more people killed in Chamba district. officials said on Thursday.

Twenty-one of these deaths were in the three major landslides in Shimla alone —at the Shiva temple in Summer Hill and in Fagli and Krishnanagar. Eight people are still feared buried in the temple debris.

On Wednesday, workers at the Summer Hill landslide site retrieved the body of P L Sharma, head of the Mathematics department at Himachal Pradesh University, Shimla Superintendent of Police Sanjeev Kumar Gandhi told PTI.

Two rain-related deaths were reported in Chamba district where a person fell from a height and another drowned, taking the death count over the past four days to 74, according to the state emergency operation centre.

The state recorded heavy rains for three days, beginning Sunday. After Tuesday, there has been less rain. There were light showers at some places on Thursday.

Since the onset of the monsoon on June 24, 217 persons have died in rainrelated incidents in Himachal Pradesh. Over the last three days, 2074 people have been evacuated from these areas.

#### Real-time flood updates

Amid a rise in flood-related incidents in the country, including loss of life and property, the government Thursday launched an app to disseminate real-time information on the flood situation in affected areas.

The FloodWatch app, will collect data from 338 stations to send real-time flood updates across 23 states and Union Territories, Central Water Commission Chairperson Kushvinder Vohra said. The app aims to use mobile phones to spread flood-related information and even provides forecasts for up to seven days, Vohra said while launching FloodWatch.
