**Sub: Intimation with respect to Revision in Disclosures under Regulation 7(3) read with Regulation 6(2) of the SEBI (Prohibition of Insider Trading Regulations), 2015**

In order to monitor compliances of Mrs. Juhi Agrawal (a legal heir of deceased employee of the Company), a connected person, Angel Broking Limited (**'the Company'**) has obtained disclosures in Form D for the trade in shares of the Company held by her and accordingly, filed intimations of the same with the stock exchanges in XBRL format.
