शिमला, ९ मई (जनसत्ता)।

प्रदेश में खैर के पेड़ों के कटान से संबंधित दो मामले उच्चतम न्यायालय में 10 मई को सूचीबद्ध हुए हैं। प्रदेश सरकार खैर उत्पादक किसानों को राहत प्रदान करे के लिए 'दस साल कटान कार्यक्रम' के अंतर्गत खैर के कटान पर लगाई गई शर्त हटाने और है। ऐसे में राज्य सरकार की दलील है कि सुविधा अनुसार उन्हें खैर कटान की अनुमित प्रदान करने के लिए सुप्रीम कोर्ट में अपना कानूनी पक्ष रखेगी।


