- c. approved and adopted the placement document dated May 4, 2019, in connection with the Preferential Issue (the "**Placement Document**"); and
- d. approved the confirmation of allocation note for allocation of Units to be issued to the eligible bidders in the Preferential Issue.

In relation to the Preferential Issue, we have filed the Placement Document with your office on May 4, 2019.

The meeting of the Allotment Committee of the Board commenced at 05.00 PM and concluded at 05.30 PM.
