A 24-YEAR-OLD professional photographer allegedly died by suicide at his Surat residence on Saturday, police said.

Dhaval Chauhan, a resident of Bhatena in Surat, had started a small firm with the help of two others in Adajan area last year, Udhna police said. He had got an assignment from a firm to take pictures of Prime Minister Narendra Modi's Kevadia event on Saturday and had subsequently left for the place with his two colleagues on October 29, police said.

He returned to Surat on Saturday evening, police said. Before reaching his house at Navketan apartment, where he lived with his parents and younger brother, Dhaval had called his father Sunil Jadav, a private bank employee, and informed him that he was on his

asked Jadhav, who had gone to the market with his wife, to bring some food.

When Jadhav and his wife returned home, they allegedly found Dhaval dead, police said. The body was sent to New Civil hospital for post-mortem, police added.

"After primary investigations, we have come to know that Dhaval and his two colleagues had started a photography firm from a rented premise at Adajan area in Surat. They had got an assignment to take pictures of the PM's event at Kevadia. They returned to Surat on October 31 evening. Dhaval was alone at his home after he returned from the assignment. We are yet to ascertain why he took such a step," Assistant Sub-inspector of Udhna police station Ashishbhai Manjibhai said. Police have also recorded the statements of his colleagues, he said.

Bengal madrasa teacher held for 'raising funds, bid to recruit for Al-Qaeda': NIA

New Delhi: The NIA has arrested a madrasa teacher from Murshidabad in West Bengal for allegedly being part of an Al-Qaeda module operating out of the state and Kerala. Abdul Momin Mondal, 32, was arrested by the agency Sunday for allegedly "trying to recruit members for the group" and raising funds.

"Investigation revealed that accused, Abdul Momin Mondal, was working as a teacher in Raipur Darul Huda Islamia Madrassa in Murshidabad district... and was found to be involved in a series of conspiratorial meetings convened by the members of the Al-Qaeda module. He was also trying to recruit new members for the group and was raising funds for furthering its terrorist activities. The residential premises of the accused person were searched and digital devices were seized," an NIA statement said.

This is the eleventh arrest the agency has made since September. According to NIA, the case "pertains to anti-national activities by a group of jihadi terrorists consisting of over 10 members inspired by globally proscribed terrorist organisation Al-Qaeda, who were planning to carry out anti-national and terrorist activities at different locations in India, including, but not limited to West Bengal, Delhi and Kerala."
