This is in continuation to our disclosure dated July 29, 2023 (Ref- IGAL/SECT/07-23/10) filed under Regulation 30 of SEBI LODR Regulations in relation to the notice received by the Company from DGCA imposing penalty of INR 30 Lakh.

The details required under Regulation 30 of SEBI LODR Regulations (as amended) are as follows:

Name of the authority(s);	Directorate General of Civil Aviation ("DGCA")
Nature and details of the action(s), initiated or order(s) passed	The Company had received show cause notice dated July 3, 2023, alleging four tail strike incidents on A321 aircraft within a span of six months in the year 2023 to which the Company had filed its response vide its letter dated July 17, 2023. Thereafter, DGCA had issued order dated July 28, 2023, imposing penalty of INR 30 Lakh.
	The Company had filed an Appeal against the said Order. DGCA considered submissions made by the Company in support of the Appeal and revised the penalty to INR 20 Lakhs vide its Order dated October 13, 2023, to be paid within 30 days of the Order. Accordingly the penalty was paid on November 9, 2023.
