This has reference to:

- (i) our letters dated 23rd March, 2020 and 25th March, 2020 informing about closure of operations at Company's various offices, plants (except Biomass Power Generation Plants at Uniara and Padampur, in the State of Rajasthan) and project sites; and
- (ii) our letter dated 21st April, 2020 regarding resumption of partial operations.

In this regards, we would like to update that the Company has resumed operations at its Raipur manufacturing Plant. Further, the Company has also resumed pre-production activities at its Gandhinagar manufacturing Plant today and will resume production activities from tomorrow. The operations at both the manufacturing Plants have been/will be resumed in accordance with the directions and approvals/permissions received from concerned Authorities/District Administration and in compliance with MHA Order dated 15th April, 2020.

Considering the prevailing uncertainties, it is difficult at this point to ascertain the impact of disruption in our operations caused by COVID-19.

The Company has taken measures and put necessary systems in place in line with Standard Operating Procedures (SOPs) for social distancing as per MHA Order and directions issued by local authorities and keeping in view of the health and well-being of all workers and employees.
