SUMMARY OF THE PROCEEDINGS OF THE 73rd ANNUAL GENERAL MEETING

a) Date, time and venue of the Annual General Meeting:-

The 73rd Annual General meeting ("AGM") of the Company was held on Wednesday, 30th September, 2020 through Video Conferencing (VC) / Other Audio-Visual Means (OAVM). The Meeting commenced at 11.05 a.m. and concluded at 11:20 a.m.

b) Proceedings in brief:

- Ms. Sanjyot Rangnekar, Chairperson of the Company chaired the meeting. The requisite quorum being present, the Chairperson called the meeting to order.
- The Chairperson informed that the Meeting was held through VC/ OAVM in compliance with the circulars issued by the Ministry of Corporate Affairs, Government of India and Securities and Exchange Board of India.
- The Chairperson informed that remote e-voting commenced at 9:00 a.m. on Sunday, September 27, 2020 and concluded at 5:00 p.m. on Tuesday, September 29, 2020.
- The Chairperson informed the Members that Mr. Shravan Gupta, Practicing Company Secretary was appointed as the Scrutiniser to scrutinise the voting through electronic means (i.e. remote evoting and voting at the meeting by using electronic system).
- With the consent of the Members, the Notice convening the Meeting and the Auditor's Report were taken as read.
