Pursuant to the provisions of SEBI (Prohibition of Insider Trading) Regulations, 2015, and Company's Code of Conduct for Prevention of Insider Trading, the Company has already informed the Stock Exchanges vide its letter dated September 28, 2023 that the window for trading in securities of the Company for the Designated Employees, Directors and their relatives, Auditors, Connected Persons, etc. would remain closed from October 1, 2023 till the expiry of 48 hours after the declaration of unaudited financial results for the quarter and half year ended September 30, 2023 and accordingly, the trading window shall remain closed till Monday, October 23, 2023 and shall re-open thereafter.
