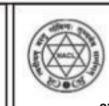

जनसत्ता ब्यूरो नई दिल्ली, 27 जनवरी।

आम आदमी पार्टी (आप) के राष्ट्रीय संयोजक व दिल्ली के मुख्यमंत्री अरविंद केजरीवाल ने शुक्रवार को केंद्र सरकार पर आरोप लगाया कि केंद्र सरकार ने दिल्ली में आप सरकार के हर काम को रोका है। केजरीवाल ने कहा कि जो काम हम दिल्ली में नहीं कर पाए, वे काम पंजाब में किए जाएंगे और पंजाब को दुनिया का नंबर एक प्रदेश बनाएंगे। केजरीवाल पंजाब में चार सौ मोहल्ला क्लीनिक की शुरुआत करने के लिए पहुंचे थे। इस मौके पर पंजाब के मुख्यमंत्री भगवंत मान भी उपस्थित थे।

पंजाब में पांच सौ मोहल्ला क्लीनिक शुरू।

उच्चतम न्यायालय ने 1985 के हत्या के एक मामले में पिछले तीन दशक से कार्यवाही का सामना कर रहे दो लोगों को संदेह का लाभ देते हए बरी कर दिया।

न्यायमुर्ति रविंद्र भट और दीपांकर दत्ता की पीठ ने दोनों लोगों की दोषसिद्धि की पृष्टि वाले इलाहाबाद हाईकोर्ट के आदेश को रद्द कर दिया है। सेशन अदालत ने 29 जनवरी 1986 को उन्हें दोषी

ठहराया था और उम्रकेद की सजा दी थी। इलाहाबाद हाईकोर्ट ने भी नौ जुलाई 2014 को दोषसिद्धी की पष्टि कर दी थी। उच्चतम न्यायालय ने कहा कि दोषी अपीलकर्ताओं ने नारायण की हत्या की, यह कहा नहीं जा सकता। उनके दोषी होने को उचित संदेह से परे साबित नहीं किया जा सकता है, इसलिए वे संदेह के लाभ के हकदार थे और हैं। पीठ ने कहा कि सुधार गृह में बंद अपीलकर्ता अगर किसी अन्य मामले में वांछित नहीं हैं तो उन्हें तुरंत रिहा कर दिया जाएगा।
