Q1FY25 Results

For the Q1 FY 2025 we reported a total income of Rs.513.7 crores as against Rs.386.6 crores reported in Q1 FY 2024 showing a growth of 33%.

The company reported an EBIDTA of Rs.64.8 crores in Q1 FY 2025 as against Rs.50.1 crores in Q1 FY 2024 showing a growth of nearly 30%. The EBIDTA % stood at 12.62% for the Q1 FY 2025.

We have reduced our interest costs; our interest costs as a percentage of sales are at 0.53% in Q1FY 2025 as compared to 0.80% reported in the same period last year.

Similarly, the Profit before Tax stood at Rs.56 crores for Q1 FY 2025 as against Rs.42.6 crores for Q1 FY 24. The PBT grew by around 32%.

Our Net Profit before minority interest stood was at Rs.40.5 crores as against Rs.33.6 crores reported in Q1 FY 2024 showing a growth rate of 20.5%. On a QoQ basis our net profit before minority interest has grown by 102%.
