

ORDER

IA/159 of 2021

This application is filed for seeking extension of 30 days and exclusion of 65 days of lock down.

Learned Counsel for the Applicant states that in 17th CoC meeting held on 02.08.2021 at Agenda Item No. 6 the issue of seeking extension and exclusion was deliberated by the member of the CoC. Accordingly, the Resolution was passed with 100% voting share. The copy of the minutes of CoC meeting and voting result are annexed with the application.

The Agenda approving the seeking of extension/exclusion of the CIRP period is mentioned in the minutes of the meeting and prayer of the application. The prayer for extension of 30 days and exclusion of 65 days of Lock down period has been made prayed. Learned Counsel for the Applicant RP states that in view of the further development 30 days extension be considered and granted so that an appropriate application can be file for approving of Resolution plan.

The Learned Counsel for the applicant further states that application for approving of Resolution plan is ready in view of the 30 days be granted so the same can be filed immediately.

Having heard submissions of the Learned Counsel for the applicant and material available on record we allow extension by further 40 days after expiry of 330 days from 13.08.2021, which is expired within two-three days, hence, suo-moto we extend the period of CIRP for 45 days for filing further application.

This application is allowed and stands disposed of.
