Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, we write to inform you that the Administrative Committee of the Board of Directors of the Company has, at its meeting held today, i.e. 14th March, 2019 approved the allotment of 4,04,480 Equity shares of face value of Rs. 2 each at a conversion premium of Rs.2,688 per share pursuant to optional conversion of 10,112 CCDs of face value of Rs.1,07,600 each aggregating to Rs. 1,08,80,51,200. These Equity shares are proposed to be listed on BSE Limited and National Stock Exchange of India Limited.
