a)	Brief Details of Litigation	A demand was raised on Vedanta Limited (SEZ Unit), at Bhurkhamunda Jharsuguda having Captive Generating Plant (CGP) of 1800 MW (3 x 600 MW) towards loss of CGP status pertaining to FY 2015-16 based on the report from Chief Electrical Inspector on June 28, 2023. Due to non-payment, DC notice was issued on August 16, 2023. Upon receipt of the DC notice the party has moved to Odisha Electricity Regulatory Commission (OERC) for quashing of the demand raised by TP Western Odisha Distribution Limited (TPWODL). The matter has been registered as case no.81 of 2023 for which notice has been received by TPWODL today. The matter is listed for hearing on September 5, 2023.
