With reference to the captioned subject matter and pursuant to SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015, we would like to inform you that due to the severe cyclonic storm "Tauktae" hitting the shores of Maharashtra & Gujarat on 18/05/2021, we have witnessed some disruption at our Ratnagiri plant in Maharashtra.

As per the initial assessment, the cyclone has caused damage to the factory sheds, which has resulted into temporary production halt at Unit I to V. The Plant production has been partly shut down and all measures are being taken to start the repair work on immediate basis. The company is also ensuring the safety of personnel and manufacturing equipment.

In this evolving situation, the overall adverse impact on the operations of the Company is not immediately assessable.
