**Bihar's centenary pillar ready for unveiling by PM Modi**

**PATNA:** A ceremonial pillar topped with an ornate bronze sculpture depicting the emblem of Bihar and erected in the state Assembly premises to mark the centenary of its iconic building is all set to be unveiled by Prime Minister Narendra Modi on July 12. On Sunday morning, workers were giving finishing touches to the tall obelisk that has been mounted in a garden opposite the central portico of the majestic landmark.

## 5 killed, 10 injured in 3 separate road accidents in Rajasthan

**JAIPUR:** Five people, including a couple, were killed and 10 others were injured in three separate road accidents in Rajasthan, police said. The incidents occurred in Nagaur, Banswara and Sirohi districts of the state. Police said that a couple travelling in a car was killed while two others were injured in a collision between a truck and a car in Devda village of Khamera police station area of Banswara late Saturday night. The deceased were identified as Himanshu (47) and his wife Deepika (40), they said.

## Armyman cycles from Bluru to Kanyakumari in 36 hrs

**BENGALURU:** The monsoon rains did not deter craftsman of the Army Base Workshop Rahul Kumar to cycle 650 km in 36 hours, from Bengaluru to Kanyakumari between July 8-9. By doing so, he tried to set a new India Book of Records for the 'Fastest Solo Cycling (men)', a statement said. "The route went through Hosur, Salem and Madurai. The temperature was normal. But, it was raining. India Book of Record monitored the ride online," the statement said.

## UP STF busts illegal arms factory in Mainpuri; 9 held

**LUCKNOW:** The STF of the Uttar Pradesh Police has arrested nine members of a gang that was allegedly running an illegal arms factory in Mainpuri district. The gang was allegedly involved in inter-state smuggling of illegal arms, the STF said in a statement on Sunday, adding that manufactured and semi-finished arms and equipment were seized from their possession. According to the statement, the STF had recently received information about the gang.

## Army focuses on teaching Mandarin to its personnel

**NEW DELHI:** In the backdrop of a lingering border row in eastern Ladakh, the Army has upscaled its efforts to impart Chinese language training to its personnel as part of the overall strategy to ramp up surveillance along the over-3,400-km LAC. A slew of measures has been undertaken to improve its in-house Mandarin expertise with an aim to empower junior and senior commanders to engage with Chinese military personnel as and when the situation demands.

## Kejriwal, Mann to lead AAP's Tiranga Yatra in Palampur

**NEW DELHI:** Delhi Chief Minister and AAP national convener Arvind Kejriwal will visit Himachal Pradesh this week to participate in a Tiranga Yatra organised by his party's state unit in Palampur in the run up to the assembly polls in the hill state. Punjab Chief Minister Bhagwant Mann will also visit the state to join Kejriwal in the event scheduled to be held in the assembly constituency on Tuesday, the party said on Sunday.

## Over 10,000 fire incidents in Delhi till June 30

**NEW DELHI:** The national capital witnessed over 10,350 fire incidents in the first six months of the year claiming lives of 60 people and injuring 395 others, the Delhi Fire Service (DFS) said. According to the data accessed by PTI, the year has so far been busy for the operators at the DFS control room, who attended 16,763 calls between January 1 and June 30 this year.

## BJP gears up to expand footprints in south India

**NEW DELHI:** After the NDA government came to power at the Centre in 2014, the Bharatiya Janata Party has seized power in various states including those in northeast India and now the party is trying to make inroads into southern states where, except Karnataka, it has not been considered as a major player and traditionally regional parties run the show. that the Congress in Goa is weakened and to engineer defections. This conspiracy was led by 2 of our own leaders - Michael Lobo and Digambar Kamat," Goa in-charge Dinesh Gundu Rao said.

"Both these people had been working in tandem with the

BJP. One person - Kamat - did it to shield himself because he is embroiled in so many cases and the other person - Michael Lobo - has succumbed to the lure of power and position. The BJP wants to finish off the Opposition," he added.

Sources said five MLAs - Michael Lobo, Delilah Lobo, Digambar Kamat, Kedar Naik and Rajesh Faldeesai - are reportedly at the CM's house. Kamat, party's CM nominee in the elections, had skipped a meeting of MLAs on Saturday.

A party meeting on Sunday also saw less-than-full attendance. Eight MLAs need to leave Congress so that anti-defection law doesn't come into play. Meanwhile, Girish Chodankar alleged that party MLAs were offered Rs 40 crore to join the BJP.

## NDRF carries out nationwide security audit of passenger ropeways, cable cars

NEW DELHI

The NDRF has begun a nationwide survey of passenger cable cars and ropeway systems to find out possible security flaws in them and to prepare a structural blueprint that will help it launch effective rescue operations in case of an emergency or accident.

# Varavara's permanent medical bail plea to be heard today

NEW DELHI

The Supreme Court is scheduled to hear on Monday a plea filed by Telugu poet and an accused in the Bhima Koregaon-Elgar Parishad case, P Varavara Rao, challenging a Bombay High Court order that rejected his prayer for permanent medical bail in the matter.

A three-judge bench of justices U U Lalit, S Ravindra Bhat and Sudhanshu Dhulia is likely to take up the matter.

Rao, in his appeal against the April 13 Bombay High Court order filed through advocate Nupur Kumar, said, "The petitioner, an 83-year-old renowned Telugu poet and orator who has undergone over two years of incarceration as an under-trial and is currently en-

larged on bail on medical grounds by the Bombay High Court, respectfully submits that any further incarceration would ring the death knell for him as advancing age and deteriorating health are a fatal combination." Rao said he has challenged the high court order as he was not granted an extension of bail despite his advanced age and precarious and deteriorating health condition, and his prayer to shift to Hyderabad was also denied.

He was arrested on August 28, 2018 from his Hyderabad residence and is an under-trial in the Bhima Koregaon case for which an FIR was lodged by the Pune police at the Vishrambagh police station on January 8, 2018 under various sections of the IPC and the UAPA.

## Murmu arrives in Bengaluru to seek support

Bengaluru: The presidential candidate of NDA Draupadi Murmu arrived here to a rousing welcome on Sunday. According to the BJP activists, Murmu came by a private jet. Karnataka CM Bommmai, BJP president Nalin Kumar Kateel and several other functionaries of the party received Murmu at the airport and greeted her with a shawl, Mysuru 'peta' (turban) and garland. # It's a serious matter: Jaishankar

NEW DELHI:

External Affairs Minister S Jaishankar on Sunday called the economic crisis in Sri Lanka a "serious" matter and highlighted India's help to the island nation.

The EAM said the Centre has pledged USD 3.8 billion to support Sri Lanka amid its economic crisis this year alone.

He emphasised that managing finances is a bigger issue and India's focus is on helping Sri Lanka.

India stands with the people of Sri Lanka as they seek prosperity and progress through democratic means and constitutional framework and continue to follow the development in the island country, the Ministry of External Affairs said.



**WHAT DID THE EAM SAY?**

- The Sri Lankan crisis is a serious matter. It is something which has been built over a period of time. Prime Minister Modi has a policy called 'Neighbourhood First.' We try and support our neighbours in a way which meets their requirements.
- We had given Sri Lanka a line of credit, which has kept essential commodities flowing to them for the past several months. We have also provided them a line of credit for the purchase of fuel. This year alone, we have pledged \$3.8 billion in support to Sri Lanka
- There is a bigger issue about how you manage your finances...About how you have a prudent fiscal policy. There are issues pertaining to the management of the economy. Our focus is on helping them.

**NEW DELHI:** India has provided 44,000 tonnes of urea to Sri Lanka for meeting the domestic requirements in the current and next sowing seasons, Union Chemicals and Fertilisers Minister Mansukh Mandaviya said on Sunday.

# Cong hurting BSP in Raj by indulging in horse-trading: Mayawati

NEW DELHI

BSP leader Mayawati on Sunday accused the Congress in Rajasthan of hurting her party by indulging in horse-trading instead of taking on the BJP, and asked her party leaders to let go of people who are ready to betray the party philosophy for monetary gains.

In a meeting with Bahujan Samaj Party leaders from Rajasthan here, she also slammed the BJP for allegedly furthering its narrow po-

litical interests using the recent killing of a tailor in Udaipur.

In a statement, the BSP quoted Mayawati as saying that while the Congress government in Rajasthan failed to assess the situation and could not provide a sense of security to the people, the BJP was busy furthering its narrow political interests following the Udaipur incident.



The Congress and the BJP should end appeasement of elements out to create chaos, she said.

She also claimed that the new "contractual" military recruitment scheme Agnipath has created a lot of disappointment in the hard-working youth of Rajasthan and urged the government to take note of it.

The government unveiled the Ag-

nipath scheme on June 14. Under the scheme, those aged between 17-and-a-half and 21 years will be inducted into the armed forces for a four-year tenure and 25 per cent of them will be inducted for regular service subsequently.

The former UP CM also questioned the BJP's "new-found love" towards Pasmanda Muslims and said every section of society is suffering due to unemployment and spiralling prices of essential commodities.

## Maha rains: Nine dead in last 24-hr

MUMBAI

As many as nine people have lost their lives due to incessant rainfall and its related incidents in Maharashtra in the last 24 hours, the State Disaster Management Department informed on Sunday.

According to the Maharashtra SDMD, a total of 76 people have died since June 1 and as many as 838 houses were damaged due to the rain-related incidents in the state.

"At least 4,916 people have been shifted to safer locations, and 35 relief camps were set up by the disaster management department and rehabilitation department," it said. The SDMD said 125 animals have also lost their lives in rain/flood-related incidents in Maharashtra since June 1. Several parts of Maharashtra have witnessed heavy rainfall over the past few days amidst the wet spell on the state since the onset of a torrential monsoon. The capital city has been witnessing heavy rain since Monday following which areas are waterlogged and traffic movement has been affected.

On Tuesday, a landslide incident was reported in Ghatkopar's Panchsheel Nagar amidst heavy rains, which demolished a house.

Raj: 5 killed, 10 injured in 3 separate road accidents

JAIPUR: Five people, including a couple, were killed and 10 others were injured in three separate road accidents in Rajasthan, police said. The incidents occurred in Nagaur, Banswara and Sirohi districts of the state. Police said that a couple travelling in a car was killed while two others were injured in a collision between a truck and a car in Devda village of Khmera police station area of Banswara late Saturday night. The deceased were identified as Himanshu (47) and his wife Deepika (40), they said.

Armyman cycles from B'luru to Kanyakumari in 36 hrs

BENGALURU: The monsoon rains did not deter craftsman of the Army Base Workshop Rahul Kumar to cycle 650 km in 36 hours, from Bengaluru to Kanyakumari between July 8-9. By doing so, he tried to set a new India Book of Records for the 'Fastest Solo Cycling (men)', a statement said. "The route went through Hosur, Salem and Madurai. The temperature was normal. But, it was raining. India Book of Record monitored the ride online," the statement said.

UP STF busts illegal arms factory in Mainpuri, 9 held

LUCKNOW: The STF of the Uttar Pradesh Police has arrested nine members of a gang that was allegedly running an illegal arms factory in Mainpuri district. The gang was allegedly involved in inter-state smuggling of illegal arms, the STF said in a statement on Sunday, adding that manufactured and semi-finished arms and equipment were seized from their possession. According to the statement, the STF had recently received information about the gang.

Army focuses on teaching Mandarin to its personnel

NEW DELHI: In the backdrop of a lingering border row in eastern Ladakh, the Army has upped its efforts to impart Chinese language training to its personnel as part of the overall strategy to ramp up surveillance along the over-3,400-km LAC. A slew of measures has been undertaken to improve its in-house Mandarin expertise with an aim to empower junior and senior commanders to engage with Chinese military personnel as and when the situation demands.

Kejriwal, Mann to lead AAP's Tiranga Yatra in Palampur

NEW DELHI: Delhi Chief Minister and AAP national convener Arvind Kejriwal will visit Himachal Pradesh this week to participate in a Tiranga Yatra organised by his party's state unit in Palampur in the run up to the assembly polls in the hill state. Punjab Chief Minister Bhagwant Mann will also visit the state to join Kejriwal in the event scheduled to be held in the assembly constituency on Tuesday, the party said on Sunday.

Over 10,000 fire incidents in Delhi till June 30

NEW DELHI: The national capital witnessed over 10,350 fire incidents in the first six months of the year claiming lives of 60 people and injuring 395 others, the Delhi Fire Service (DFS) said. According to the data accessed by PTI, the year has so far been busy for the operators at the DFS control room, who attended 16,763 calls between January 1 and June 30 this year.

BJP gears up to expand footprints in south India

NEW DELHI: After the NDA government came to power at the Centre in 2014, the Bharatiya Janata Party has seized power in various states including those in northeast India and now the party is trying to make inroads into southern states where, except Karnataka, it has not been considered as a major player and traditionally regional parties run the show. Keeping up with its South India push, the BJP recently organised its national executive committee meeting in Hyderabad.

Accusing the ruling party of spreading rumours about a split in Congress, Goa PCC President Amit Patkar said that all the MLAs are together and they have refused any possibility of a split.

Amidst the said rumours of Congress leaders joining the BJP, the incharge of the AICC of Goa, Dinesh Gundu Rao said, "Yesterday we had a CLP meeting in Goa. All the MLAs are intact but BJP is trying to poach our MLAs and intimidate them. But all the MLAs are intact."

NDRF carries out nationwide security audit of passenger ropeways, cable cars

NEW DELHI: The NDRF has begun a nationwide survey of passenger cable cars and ropeway systems to find out possible security flaws in them and to prepare a structural blueprint that will help it launch effective rescue operations in case of an emergency or accident.

The federal contingency force has also decided to train its rescuers in specific ropeway rescue skills apart from purchasing an assortment of tools like pulleys and carabiners to be used for transporting the salvager and evacuating stranded people from the car hanging in the air.

The move comes in the backdrop of at least three reported ropeway accidents that took place in Jharkhand, Himachal Pradesh and MP this year.

Three people were killed while 12 were rescued after a 40-hour-long operation conducted by the Indian Air Force, NDRF, Army, ITBP and local administration after cable cars got trapped mid-air on a ropeway at Trikut hills in Jharkhand's Deoghar district in April.

Today, SC to hear Varavara's permanent medical bail plea

NEW DELHI

The Supreme Court is scheduled to hear on Monday a plea filed by Telugu poet and an accused in the Bhima Koregaon-Elgar Parishad case, P Varavara Rao, challenging a Bombay High Court order that rejected his prayer for permanent medical bail in the matter.

A three-judge bench of justices U U Lalit, S Ravindra Bhat and Sudhanshu Dhulia is likely to take up the matter.

Rao, in his appeal against the April 13 Bombay High Court order filed through advocate Nupur Kumar, said, "The petitioner, an 83-year-old renowned Telugu poet and orator who has undergone over two years of incarceration as an under-trial and is currently en-

larged on bail on medical grounds by the Bombay High Court, respectfully submits that any further incarceration would ring the death knell for him as advancing age and deteriorating health are a fatal combination." Rao said he has challenged the high court order as he was not granted an extension of bail despite his advanced age and precarious and deteriorating health condition, and his prayer to shift to Hyderabad was also denied.

He was arrested on August 28, 2018 from his Hyderabad residence and is an under-trial in the Bhima Koregaon case for which an FIR was lodged by the Pune police at the Vishrambagh police station on January 8, 2018 under various sections of the IPC and the UAPA.

Murmu arrives in Bengaluru to seek support

Bengaluru: The presidential candidate of NDA Draupadi Murmu arrived here to a rousing welcome on Sunday. According to the BJP activists, Murmu came by a private jet. Karnataka Cm Bommali, BJP president Nalin Kumar Katele and several other functionaries of the party received Murmu at the airport and greeted her with a shawl, Mysuru 'peta' (turban) and garland. Later, Murmu went to a hotel where she addressed the BJP MLAs and MPs, seeking their support.

India seeing lot of changes over last 8 years: EAM

THIRUVANANTHAPURAM: External Affairs Minister S Jaishankar on Sunday said India has witnessed a lot of changes in the last eight years under the NDA rule and the difference was evident in a lot of sectors including digital connectivity and health care.

Jaishankar, while interacting with youth here in the state capital, said the India which he witnessed in his youth was very much different from what today's youngsters are experiencing.

"Even 10 or 15 years ago if something like COVID-19 had happened, we would have waited for what the world is doing and waited for our turn for vaccination and medicines. But today we are among the big countries which have the highest rate of vaccinations. We made our own vaccines. We are one of the few countries which have a CoWIN app which helps everyone to get vaccinated and have a digital certificate," the minister said.

Annual Amarnath Yatra suspended from Jammu due to inclement weather

JAMMU: The Amarnath Yatra has been suspended from Jammu due to inclement weather conditions and no fresh batch was allowed to proceed from here to the base camps of the 3,880-metre-high cave shrine in south Kashmir Himalayas, officials said.

A flash flood triggered by a cloudburst near the cave shrine on Friday afternoon has led to the death of at least 16 people. Around 40 people are still missing.

"Amarnath Yatra has been suspended from Jammu to twin base camps in Kashmir due to inclement weather. No fresh batch was allowed to move towards Amarnath" an official told PTI.

The annual 43-day pilgrimage commenced from the twin base camps - Nunwan-Pahalagam in south Kashmir's Anantnag and Baltal in central Kashmir's Ganderbal - on June 30. Over one lakh pilgrims have offered prayers at the cave shrine, housing the naturally formed ice 'shivling', the officials said. A total of 69,535 pilgrims have left in 10 batches from the Bhagwati Nagar base camp in Jammu for the Valley since June 29, the day the first batch of pilgrims was flagged off by Lt Governor Manoj Sinha.

The yatra is scheduled to end on August 11 on the occasion of Raksha Bandhan.

Maha rains: Nine dead in last 24-hr

MUMBAI

As many as nine people have lost their lives due to incessant rainfall and its related incidents in Maharashtra in the last 24 hours, the State Disaster Management Department informed on Sunday.

According to the Maharashtra SDMD, a total of 76 people have died since June 1 and as many as 838 houses were damaged due to the rain-related incidents in the state.

"At least 4,916 people have been shifted to safer locations, and 35 relief camps were set up by the disaster management department and rehabilitation department," it said.

The SDMD said 125 animals have also lost their lives in rain/flood-related incidents in Maharashtra since June 1.

Several parts of Maharashtra have witnessed heavy rainfall over the past few days amidst the wet spell on the state since the onset of a torrential monsoon.

The capital city has been witnessing heavy rain since Monday following which areas are water-logged and traffic movement has been affected.

The former UP CM also questioned the BJP's "new-found love" towards Pasmanda Muslims and said every section of society is suffering due to unemployment and spiralling prices of essential commodities.





मप्र राज्य नीति एवं योजना आयोग ने कहा है कि राज्य में बैंक अगले चार साल में अपने कर्ज दोगुने करें। अभी वे कुल 3.20 लाख करोड़ रुपए सालाना कर्ज बांटते हैं। 2026 तक इसे बढ़ाकर 6.70 लाख करोड़ रुपए किया जाए। आयोग ने 5 ट्रिलियन डॉलर इकोनॉमी में मप्र के योगदान को 4.6% से बढ़ाकर 11% करने के लिए एक रोडमैप तैयार किया है। सरकार इस

आधार पर बैंकों से विशेष बैठक कर कर्जों में बढ़ोतरी करने को कहेगी। अभी राज्य का सकल घरेलू उत्पाद (जीएसडीपी) 9.17 लाख करोड़ है जो 2026 तक 41.30 लाख करोड़ तक पहुंचाने का लक्ष्य है। आयोग ने सिफारिश में कहा है कि 4 साल में मेन्यूफैक्चरिंग पर खास फोकस रहेगा। अभी यह सेक्टर 84 हजार करोड़ का उत्पादन करता है जो चार साल में 1.75 लाख करोड़ हो जाएगा। इससे शहरी क्षेत्रों में बढ़े पैमाने पर रोजगार सृजित होंगे। नतीजतन शहरी आबादी 7% बढ़ जाएगी। अभी कुल आबादी का 28% हिस्सा शहरों में रहता है।



- अप्रचालित या inoperative बैंक अकाउंट में unclaimed बैलेन्स एवं लागू ब्याज का दावा किया जा सकता है\*
- बैंक अकाउंट में दो वर्ष से अधिक समय तक कोई लेन-देन न होने पर अकाउंट अप्रचालित या inoperative बन जाता है
- अपने बैंक खाते को नियमित रूप से प्रचालित (operate) करते रहें ताकि वह अप्रचालित (inoperative) न बने। अगर अकाउंट इस्तेमाल में न हो तो उसे बंद कर दें
