New import policy may help paper stocks turn a page

Compulsory registration under PIM positive for medium to long term, say analysts

New Delhi, 27 May

hares of paper companies were in demand on Friday, after the government stepped up scrutiny on paper imports. The stocks of West Coast Paper, JK Paper, Star Paper Mills, Andhra Paper, and Orient Paper surged between 0.8 per cent and 3.6 per cent on the BSE.

In an effort to curb the illegal dumping of paper materials, the government has amended its import policy for compulsory registration under the paper monitoring system (PIM). Under this, an importer will have to provide advance information about the import of paper and obtain a registration number. The importer can apply for registration five days before the expected date of arrival of import consignment, whereas the automatic registration number shall remain valid for 75 days.

Analysts believe the government's nascent step towards an anti-dumping policy will act as a big booster for domestic paper players. "The domestic paper industry has been voicing its concerns on dumping and this move shall bring a much-awaited relief to the sector. This comes at a time when paper mills have raised their prices to fully neutralise the impact of rising raw material costs," said S Ranganathan, head of research at LKP Securities

Analysts expect leading paper players like West Coast Paper and JK Paper to benefit from the new import policy, auguring domestic production, as well as bolstering exports of higher paper volumes.

'The government's compulsory registration of paper imports is sentimentally positive for the entire domestic paper industry. The new import policy gives the upper hand to bigger paper players, such as JK Paper and West Coast Paper, to export more due to higher production capacity than smaller players

India's exports of paper and paperboard jumped nearly 80 per cent in 2021-2022, fetching a record ₹13,963 crore. In terms of volumes, paper exports have grown fourfold to 2.85 mt in the past five years, reports suggest.

And now, with the new import policy effective from October 1 and the resurgence in demand after Covid, analysts expect the domestic paper industry to benefit over the medium-to-long term. "The new import policy will enable the government to observe and monitor for the next six months if the domestic industry is hurt by these imports. Hence, the next step from dumping duty, which is six-totwelve months away. We expect paper stocks to potentially benefit from the new import policy in the long haul," said Deepak Jasani, head of retail research, HDFC

Raw material cost

But the sharp increase in global pulp prices, coupled with high raw material costs, had compelled companies to take a 10-12 per cent price hike in April and May. While the inflated pulp price is good news for larger paper players, smaller players will face the heat due to lower utilisation levels.

"Since global pulp prices have risen significantly in the past year, international paper prices are on the rise too. We expect JK Paper to gain more than other paper players because of higher global prices and benefits from Covid-led supply disruptions. We maintain a "buy" stance on JK Paper with a target price of ₹420 per share," said Dua.

That apart, according to the Indian Paper Manufacturers Association (IPMA), paper consumption in India is likely to witness 6 per cent-7 per cent growth per annum in the next five years, driven by growth in organised retail and education emphasis. The industry body expects paper consumption to reach 30 mt by FY27, with an estimated turnover of ₹70.000 crore

Manage cash flow mismatches with loan against securities

Tata Capital recently launched loans against shares. The lender will offer loans of up to ₹5 crore through a completely digitised process Several other banks and nonbanking financial companies (NBFCs) also offer loans against a variety of securities: Mutual funds, debentures, insurance policies, sovereign gold bonds, National Savings Certificates, and so on.

Don't sell securities, borrow against them

These loans are easy to get. 'Customers can get quick access to funds in a manner that is simple and convenient," says Abonty Banerjee, chief digital officer, Tata Capital.

Since these are secured loans, they are less expensive than personal loans, which are unsecured. "Most personal loans are priced at around 9.5 per cent or more. Loans against securities could be priced as low as 7.65 per cent. Loans against fixed deposits (FDs) are usually priced just 1-2 percentage points above the FD rate," says Adhil Shetty, chief executive officer

(CEO), BankBazaar. The borrower gains access to funds without having to liquidate his securities. "She will continue to receive the credit of dividends, interest, bonuses, etc. on the pledged securities during the loan tenure." says Gauray Aggarwal, senior director, Paisabazaar.com.

This loan can also be obtained as an overdraft facility. A credit limit is sanctioned to the borrower on the basis of the loan-to-value (LTV) ratio set for the pledged securities. "The borrower is free to draw the entire sanctioned limit or a part of it depending on her requirements. She can draw up to the sanctioned limit and repay any number of times till the overdraft facility expires. Interest is charged only on the drawn amount and for the tenure for which the money is utilised," adds Aggarwal.

flow mismatches. "Those who lack credit history stand a better chance of getting this type of loan if they can offer securities as collateral," says Rishi Mehra, CEO, Wishfin.

Risk of forfeiture

When a borrower takes a loan against securities, a lien gets

marked on them. The lender can take over those securities if she delays or defaults. Volatile markets pose

a risk when marketlinked securities are pledged. "If the value of YOUR the pledged shares or mutual fund units drops. **MONEY** the lender may ask the borrower to deposit

additional security or cash," says Shetty. Aggarwal adds that failure to furnish this can attract penal interest rates on the amount borrowed in excess of the sanctioned LTV ratio.

Investors sometimes take loans against securities to take leveraged bets in the markets. "This is a risky undertaking that can backfire." says Deepesh Raghaw, founder, PersonalFinancePlan, a Securities and Exchange Board of India-registered investment advisor.

Points to heed

Each lender has its own list of approved securities. The LTV ratio for each type of security can also vary across lenders, subject to the regulatory cap on LTV ratios set by the Reserve Bank of India (RBI). "Applicants should find out whether their investments are included in the list of approved securities, and then compare the LTV ratios assigned by various lenders," says Aggarwal.

The tenure of these loans should ideally be limited to one or at most two years. If you have a two-year loan, and the market corrects sharply at the end of six months, you would in all likelihood have repaid enough of your principal to ensure you don't have to provide additional collateral, or have to provide only a marginal

"If you take a five-year loan, most of your initial repayments would have gone towards paying the interest component. Very little would have gone towards reducing the principal. Hence, there would be a higher probability that you would have to provide additional collateral," says Shetty.

If you avail of this loan as a credit line. make sure you use it. "If you don't, you will end up paying a yearly fee without benefiting from it," says Mehra.


