# डॉ. पंजाबराव देशमुख कृषि विद्यापीठाचे कार्य उल्लेखनीय - राज्यपाल



सोलापूर, दि.१४ : ग्रामीण पोलिसांच्या 'ऑपरेशन परिवर्तन'चा धाक कमी झाल्याने गावठी दारूची नशा आता गावागावात चढू लागली आहे. अनेक तरुणांचा संसार या अवैध दारूमुळे उघड्यावर आल्याची वस्तुस्थिती आहे. राज्य उत्पादन शुल्क विभागाने अवघ्या साडेदहा महिन्यांत (१ एप्रिल २०२३ ते १३ फेब्रुवारी २०२४) तब्बल ५६ हजार लिटर हातभट्टी आणि साडेदहा लाख लिटर गुळमिथित रसायन नष्ट केले आहे.

राज्य उत्पादन शुल्क विभागाने (एक्सआईजे) २६० लिटर हातभट्टी व २१ हजार ६५० लिटर रसायन, द्वाकासिंह पाच लाख ४८ हजार ६०० रुपयांचा मुद्दामाल जप्त केला.ग्रामीण पोलिसांच्या तुलनेत आता राज्य उत्पादन शुल्क विभागाने 'हातभट्टीमुक्त जिल्हा' मोहिमेअंतर्गत विविध ठिकाणी छापे टाकायला सुरु केले आहे. १ एप्रिल २०२३ पासून आतापर्यंत ५६९ ठिकाणी त्यांनी छापे टाकले आहेत. हातभट्टी विक्रीप्रकरणी ३५८ तर अवैधरीत्या दारू वाहतूक केल्याप्रकरणी १०० गुन्हे दाखल केले आहेत. या कारवाईत १०६ वाहने जप्त केली आहेत. उत्पादन शुल्क अ व ब विभाग, भरारी पथक व सीमा तपासणी नाक्याच्या पथकाने दक्षिण सोलापूर तालुक्यातील हातभट्ट्यांवर धाडी टाकून दोन संशयितांना अटक केली. निरीक्षक नंदकुमार जाधव यांच्या पथकाने ही कारवाई केली. या पथकाने सीताराम तांड्यावरही धाड टाकून साडेतीन हजार लिटर रसायन नष्ट केले.

मुंबई, दि.१४ : आपल्या स्थापनेच्या ५७ वर्षांमध्ये डॉ पंजाबराव देशमुख कृषि विद्यापीठाने कृषि शिक्षण, संशोधन व विस्तार सेवा क्षेत्रात उल्लेखनीय कार्य केले आहे. वाढती लोकसंख्या, सातत्याने कमी होत असलेले कृषिक्षेत्र व हवामानातील तीव्र बदल या पार्श्वभूमीवर कृषि विद्यापीठाना आगामी काळातील आव्हानांसाठी तयार राहावे लागेल तसेच वातावरण बदलामुळे होणाऱ्या संकटांना तोंड देण्यासाठी शेतकऱ्यांना सक्षम करावे लागेल, असे प्रतिपादन राज्यपाल तथा कुलपती रमेश बैस यांनी आज येथे केले.

राज्यपाल बैस यांच्या दुरस्थ उपस्थितीत बुधवारी (दि. १४) अकोला येथील डॉ. पंजाबराव देशमुख कृषि विद्यापीठाचा ३८ वा दीक्षांत समारंभ संपन्न संपन्न झाला, त्यावेळी राजभवन येथून स्नातकांना संबोधित करताना राज्यपाल बोलत होते.

रुपांतर करावे असे आवाहन राज्याचे कृषिमंत्री व विद्यापीठाचे प्रकुलपती धनंजय मुंडे यांनी दृक्शाव्य माध्यमातून संबोधित करताना केले. कृत्रिम प्रज्ञा तंत्रज्ञानामुळे कृषि क्षेत्राचा मोठा
