Pursuant to Regulation 30 of the Listing Regulations, we wish to submit that Zomato Malaysia Sdn. Bhd ("**Zomato Malaysia**"), step down subsidiary of Zomato Limited ("**the Company**") situated in Malaysia has initiated the process of liquidation w.e.f. February 15, 2024.

Further, as disclosed in our red herring prospectus dated July 6, 2021 and prospectus dated July 19, 2021, Zomato Malaysia does not have any active business operation.

It may be further noted that Zomato Malaysia is not a material subsidiary of the Company, and the dissolution of Zomato Malaysia will not affect the turnover/revenue of the Company.
