This is with reference to the letter dated June 20, 2020 shared by Baid Leasing and Finance Co. Ltd. ("Company") intimating your good office that meeting of the Board of Directors of the Company shall be held on Tuesday, June 30, 2020, inter alia for the consideration and approval of Audited Financial Results for the quarter and year ended on March 31, 2020.

Subsequent to the aforesaid intimation, the Securities and Exchange Board of India vide circular number SEBI/HO/CFD/CMD1/CIR/P/2020/106 dated June 24, 2020 acknowledged the difficulties faced by Companies on account of the CoVID-19 pandemic and extended the timeline for submission of Financial Results under Regulation 33 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, by a month, to July 31, 2020, for the quarter and the year ended March 31, 2020. ("Extension Notification").

Due to practical/logistical challenges in light of the CoVID-19 pandemic and in light of the issuance of the Extension Notification, the meeting of the Board of Directors of the Company earlier scheduled to be held on Tuesday, June 30, 2020 has been postponed and rescheduled to be held on Tuesday, July 21, 2020 at 04:00 P.M. at the Registered Office of the Company situated at "Baid House", IInd Floor, 1, Tara Nagar, Ajmer Road, Jaipur 302006 (Rajasthan) interalia to consider the following:

- Approval of Audited financial results for the quarter and year ended on March 31, 2020 along with the statement of assets and liabilities as on that date and cash flow statement for the year ended on 31st March, 2020 and to take on record Auditor's report thereon.
- 2. The proposal of raising of funds through issue of Non- Convertible Debentures (NCDs), in one or more tranches, subject to approval of Shareholders.
