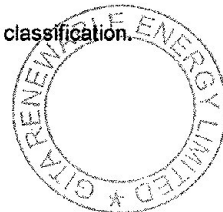
Notes :

To The Board of Directors GITA RENEWABLE ENERGY LIMITED

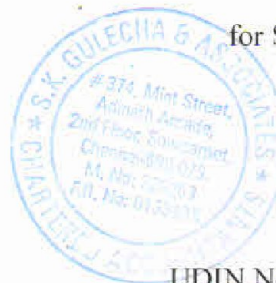
