#### 'Alliance Won't Be Dettered By **Petty Politics'**

New Delhi: Congress on Tuesday led the opposition in arguing that PM Narendra Modi is worried about the opposition INDIA traction, which prompted him to decide to change the name of the country to "Bharat". The opposition parties also highlighted the INDIA alliance's slogan of "Judega Bharat, Jeetega INDIA", arguing the two names are interchange-

Congress' K C Venugopal said, "BJP's destructive mind can only think of how to divide people. Once again, they are creating a rift between Indians and Bharatiyas ... This is petty politics because they are scared of INDIA (alliance)."

RJD's Tejashwi Yadav said, "If the PM has an objection to the word INDIA, he should have an objection to Bharat as well since our slogan carries both the names in the tagline"

AICC spokesman Jairam Ramesh said PM Modi can "distort the history and divide India" but the alliance will not be deterred

Party MP Shashi Tharoor hoped that the government will not be foolish enough to "completely dispense with 'India' which has incalculable brand

The parties also reminded BJP that the government had come up with the slogans and schemes like "Digital India", "Start-Up India", "New India".

West Bengal CM Mamata Banerjee questioned the need to "suddenly use only Bharat". "We all say 'Bharat', what is new in this? The world knows us as India. What happened suddenly that the name of the country needs to be changed?" she asked. "They (BJP) are alTOT LINE OF NO CONTROL



#### Text of Prez's dinner invite finalised by MEA

he President's dinner invite to G20 delegates, describing her as 'President of Bharat' instead of the customary President of India, was firmed up by the ministry of external affairs, the programme's host, and not Rashtrapati Bhavan.

Usually, the text of invitations extended by Rashtrapati Bhavan for programmes held at President House are prepared by the President's secretariat. However, in the case of the G20 summit, the MEA, as host ministry, has been overseeing preparations and invites. As a result, the text of the invite was issued by the ministry on behalf of the President, the RSVP of which, as the invite says, is also to be directed to the MEA's

This is the first instance when 'President of Bharat' has replaced the customary 'President of India' communication by Rashtrapati Bhawan. Sources could not confirm whether the change was permanent, and all invites from Rashtrapati Bhavan would, henceforth, prefer the new usage over the way the President has been addressed so far. TNN

# BJP: Name 'Bharat' marks country's 'civilisational march'

New Delhi: BJP on Tuesday reacted with delight to a G20 dinner invitation which described Droupadi Murmu as "President of Bharat", saying the use of the Hindi name for the country underscores its "civilisation march" even as the party dismissed the opposition's objections to

Union ministers Dharmendra Pradhan and Giriraj Singh later posted the pictures of their invite on X. Sharing a picture of his invite, Pradhan said, "Jana Gana Mana Adhinayak Jaya He, Bharat Bhagya Vidhata."

Assam CM Himanta Biswa Sarmasaid, "Republic of Bharathappy and proud that our civilisation is marching ahead boldly towards Amrit Kaal."

Rejecting the opposition's criticism, he said, "The name Bharat is mentioned in the Constitution and the country has been known by it for thousands of years ... In this Amrit Kaal people want that their country's name should be known as Bharat. Why should it have an English name. What is the problem of Congress?"

In a sarcastic reference to Rahul Gandhi, Sarma said the Congress leader had named his footmarch as "Bharat Jodo Yatra".

Asked if the government is planning to do away with 'India' as the country's name during the coming special session of Parliament, Union Minister Rajeev Chandrasekhar said he cannot react to speculation.

BJP general secretary Tarun Chugh said, "Bharat word is not new. It has been used since ancient times. Bharat Mata and Vande Matram is in our blood and nothing will happen by your opposition. Bharat word is mentioned in the Constitution. New Khiljis and new Mughals want to

#### Citizens free to call **India or Bharat: SC**

New Delhi: The citizens are free to call the country India or Bharat as per their wishes, the Supreme Court had said in 2016 while dismissing a PIL which sought a direction that India be called 'Bharat' for all purposes.

The apex court's summary dismissal of the PIL becomes relevant in view of a massive nation-wide debate which got triggered following the G20 dinner invitation from President Droupadi Murmu describing her position as 'President of Bharat'.

"Bharat or India? You want to call it Bharat, go right ahead. Someone wants to call it India, let him call it India," a bench of Chief Justice TS Thakur and Justice UU Lalit, both retired, had observed while trashing the PIL filed by Niranjan Bhatwal from

The Centre, facing opposition criticism over the G20 invite, had told the top court in November 2015 that the country does not have to be called 'Bharat' instead of 'India'. PTI

rors, wondering if one can expect anything from a party which does not even know the country's preamble. "Can we expect anything from a party which does not even know India's Preamble.... Congress equals to lack of respect for Constitution and Dr. Ambedkar. Shameful," he said on microblogging site X.

The BJP leader was reacting to the Congress' post claiming that it is impossible to erase India, an apparent reference to the row over a G20 invite which referred to the President as "President of Bharat" and not "President of India" as is mostly done.

However, the image of the preamble' Congress posed had typos. The word belief was written as 'brief' and the word 'solemnly' was also misspelled, as highlighted by Nadda's post, among other errors. Congress handle later deleted the post.

### Drop 'India', let it be 'Bharat' says, BJD MP Mahtab

Bhubaneswar: Six-time MP Bhartruhari Mahtab of BJD said on Tuesday that the country should officially be called "Bharat", and "India" should be permanently removed from the Constitution. He was reacting to a controversy surrounding the G20 dinner invitation, where Droupadi Murmu was referred to as the "President of Bharat".

The MP representing Cuttack in the Lok Sabha had introduced two private members' bills in 2015 and again in 2019 to remove "India" from the Constitution. "I firmly believe our country should be referred to as Bharat, a meaningful word that means the land of continuous pursuit of knowledge. It's an ancient name and is in continuity till now.

On the contrary, India was coined during the British rule with no such meaning," Mahtab said. He justified his argument by citing examples of other countries that have shed their colonial names. "Myanmar and Sri Lanka have dropped their colonial names of Burma and Ceylon, respectively. It is high time we also did," he said, suggesting that even if the name is not officially changed, everyone should be encouraged to use "Bharat" instead of "India".

Former Union minister of state and BJP MP Pratap Chandra Sarangi said continuing with "India" is akin to maintaining a colonial mindset. "The name India is a gift from the British, which doesn't properly fit any definition of the country," he said.
