Annexure – A

Summary of the proceeding of the 43rd AGM of the Company.

The 43rd AGM of the Members of Siyaram Silk Mills Limited ("the Company") was held on Saturday, 31st July, 2021 at 11.00 A.M. (IST) through Video Conferencing ("VC")/ Other Audio Visual Means ("OAVM"), on account of Covid-19 Pandemic, in accordance with directives of the Ministry of Corporate Affairs ("MCA") and Securities Exchange Board of India ("SEBI"). The meeting was chaired by Shri. Ramesh Poddar, Chairman and Managing Director.

The Company Secretary welcomed everyone present at the meeting and briefed them on certain points relating to the participation at the meeting through VC and the remote e-voting facility. The Company Secretary thereafter requested the Chairman, of the Company, to commence the meeting.

Requisite quorum being present, the Chairman called the meeting to order. He introduced all the Directors present at the meeting and informed the Members that the Statutory Registers and other relevant documents were available for inspection. The Chairman then briefed on financial highlights, review of operations and current year scenario.

With the permission of the Members, the Notice of the meeting and Annual Report 2020-21 were taken as read. The Members were informed that the Statutory Auditors' Report and Secretarial Auditors' Report had no adverse remarks and the same was thus taken as read. The Chairman informed the Members that the Company had provided the facility to cast their votes electronically on all 5 (five) resolutions set forth in the Notice. Members, who were present at the AGM and had not cast their votes electronically, only were entitled to cast their votes by e-voting and that there would be no voting by show of hands.

The following items of business, as per the Notice of AGM dated 27th May, 2021, were transacted at the meeting:

- 1. Adoption of Standalone and Consolidated Audited Financial Statements for the financial year ended 31st March, 2021 and the Reports of the Board of Directors and Auditors thereon.
- 2. To declare Dividend of Rs.4.60 per Equity Share of Rs.2/- each of the Company for the financial year ended 31st March, 2021.
- 3. Re-appointment of Shri. Pawan D. Poddar (DIN 00090521), as a Director, who retires by rotation.

- 4. Ratification of remuneration payable to M/s. Bhuta & Associates, Cost Accountants (FRN100817) as Cost Auditors for the F.Y.2021-22.
- Re-appointment of Shri. Pawan D. Poddar (DIN 00090521) as Joint Managing Director, for a further period of 3 (three) years from 1st August, 2021 to 31st July, 2024.

The Chairman thereafter invited the Members to express their views and ask questions. After receiving all the queries/ questions, the Chairman then responded on the same.

The Chairman informed the Members that the Board of Directors had appointed Shri. Prasen Naithani, Practicing Company Secretary, as the Scrutinizer to supervise the votes cast through remote e-voting and also through e-voting system at the AGM. The Chairman authorised the Company Secretary to countersign the Consolidated Results and upload the same along with Scrutinizer's report within 48 hours of the conclusion of the Meeting.

After conclusion of the meeting, the Scrutinizer's Report was received and accordingly all the resolutions as set out in the notice were declared as passed.
