Summary of the Proceedings of the 34th Annual General Meeting

This is to inform you that the 34th Annual General Meeting of the Company Polytex India Limited held on Wednesday, September 30, 2020 at the 1st Floor, Nisarg Apartment, Besant Road, Vile Parle - West Mumbai - 400056. The Meeting commenced at 10.00 a.m. and conclude at 11.00 a.m.

Mr. Paresh Kariya, Chairman chaired the meeting. The requisite quorum being present, the chairman called the meeting in order. Mr. Paresh Kariya, Director of the Company has provided satisfactory clarification to all the queries raised by the members.

The Chairman informed that pursuant to section 108 of the Companies Act, 2013 and Regulation 44 of the SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015, the company had provide to the Members the facility to cast their votes electronically in respect of all business mentioned in the notice. The remote e-voting facility kept open for a period of three days i.e. from September 27, 2020 (10.00 A.M.) to September 29, 2020 (05.00 P.M.) Members who had not cast their votes electronically were provided an opportunity to cast their votes at the meeting through Ballot Papers.

The following items of the Business as set out in the Notice of AGM were transacted at the meeting:

1. To receive, consider and adopt the audited financial statements for the financial year ended March 31, 2020 and the report of the Board of Directors and Auditors thereon.
2. Appointment of Mr Paresh Mulji Kariya, who retires by rotation and being eligible, offers himself for reappointment.
3. Ratification of appointment of M/s. Agrawal Jain & Gupta, Chartered Accountants as Statutory Auditors of the Company.
4. To Approve Re-Appointment of Mr. Paresh Mulji Kariya, Whole-Time Director of the Company for the period of 5 years.
5. To Approve Re-Appointment of Mr. Arvind Mulji Kariya, Whole-Time Director of the Company for the period of 5 years.
6. To approve Reappointment of Mr. Sachchidanand Rajaram Adam, (Din 07109630) as an Independent Director of the Company for a Second Term of Five Years.

The Chairman informed that the consolidated result of remote e-voting and voting by physical ballot on all the resolution from item 1 to 6 will be communicated to the Stock Exchange subsequently to the receipt of combined Scrutinizer's Report both on remote e-voting and voting at the aforesaid AGM.
