In compliance with Regulation 30 read with Schedule III of SEBI (LODR) Regulations, 2015 and in furtherance of our earlier letter dated February 23, 2022, in this regard, this is to inform that the Board of Directors of REC in its meeting held on March 21, 2022, has appointed Shri S K G Rahate, (DIN 05254178) as an Additional Director on the Board of REC in the capacity of Chairman and Managing Director (in additional charge), with effect from February 22, 2022, subject to the approval of shareholders of the Company.

Further, the Board in the above meeting has also approved the proposal for incorporation of a project-specific special purpose vehicle, as wholly owned subsidiary of REC Power Development & Consultancy Limited (RECPDCL), for development of inter-state transmission project at Karnataka to be implemented through tariff based competitive bidding route, allocated by Ministry of Power, Government of India. The proposed company will also be subsidiary company of REC Limited, in terms of the provisions of Section 2(87) of the Companies Act, 2013.
