1	Competition Commission of India	Alleged contravention of Competition Act, 2002		"Competition Commission of India (CCI)" vide its order dated August 31, 2016 imposed a penalty of Rs. 12,854 lacs on the Company. The appeal was heard whereupon Hon'ble National Company Law Appellate Tribunal (NCLAT) vide order dated July 25, 2018 upheld CCI's order. The Company has filed statutory appeal before the Hon'ble Supreme Court, which vide its order dated October 5, 2018 has admitted the appeal and directed that the interim order of stay passed by the Hon'ble NCLAT in this matter will continue for the time being. The Company, backed by legal opinion, believes that it has a good case and accordingly no provision has been considered in the books of accounts.
2.	Competition Commission of India	Alleged contravention of Competition Act, 2002		In a separate matter, CCI imposed penalty of Rs. 928 lacs vide order dated January 19, 2017 for alleged contravention of provisions of Competition Act, 2002 by the Company. On Company's appeal, Hon'ble NCLAT has stayed the operation of CCI's order. The matter is pending for hearing before Hon'ble NCLAT. The Company, backed by legal opinion, believes it has a good case and accordingly no provision has been considered in the books of accounts.
