भोपाल,(निप्र)। झेलम एक्सप्रेस में बम रखने की खबर अफवाह निकली। रेलवे और जिला प्रशासन की टीमों ने भोपाल में ट्रेन की सर्चिंग की, इसके बाद उसे रवाना कर दिया गया। भोपाल होकर जाने वाली झेलम एक्सप्रेस ट्रेन के एस-९ कोच में बम रखे होने की सुचना के बाद हड़कंप मच गया। बम होने की जानकारी एस-९ कोच में यात्रा करने वाले एक युवक दी। इसके बाद यात्रियों में दहशत फैल गई। तत्काल इसकी सूचना जीआरपी को दी गई। जानकारी के अनुसार झेलम एक्सप्रेस शुक्रवार सुबह साढ़े ८ बजे की जगह पर पौने ९ बजे रानी कमलापति स्टेशन पर पहंची तो जीआरपी, आरपीएफ के साथ बम डिस्पोजल और डॉग स्क्वॉड की टीम ने पूरे कोच को घेर लिया। सभी यात्रियों को बाहर निकाला गया। इसके बाद करीब एक घंटे तक पूरी ट्रेन की बारीकी से जांच की गई। जांच में किसी भी कोच में कोई भी संदिग्ध वस्तु नहीं पाई गई, इसके बाद एस-९ कोच में बैठे उस युवक को आरपीएफ ने हिरासत में ले लिया। जिसमें बम होने की सूचना दी थी। आरोपी से पूछताछ की जा रही है।

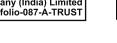
