Centre, States to Act on Easing Compliance Load



New Delhi: The centre and states will take corrective action by March 31 to reduce the compliance burden on businesses and citizens, Guruprasad Mohapatra, secretary, Department for Promotion of Industry and Internal Trade (DPIIT) said on Wednesday. He said 7,000 compliances have been identified by the ministries and states to reduce compliance burden.

"In the 75th year of India's Independence, we want to reduce the compliance burden, simplify further the citizen-government interface whether online or offline, and remove antiquated and obsolete acts which don't add value," Mohapatra said at the DPIIT-CII event on Make In India.

Mohapatra said Prime Minister Narendra Modi had called a meeting of ministries which contribute the most to this burden including finance, commerce and health.

Referring to the pandemic, the secretary said the world saw massive disruptions in supply chains and realised they have ceded manufacturing to a certain country. "Our focus is how to boost manufacturing and boosting competitiveness of Indian manufacturing and that's where we realise we are not as competitive as the country bordering us," he said. —Our Bureau

TO 1.01 Million in November

Less than 1.06 million added in October and 1.33 million added in Sept

New Delhi: The Employees' Provident Fund Organisation (EPFO) continued to see a decline in net new subscriber addition in November 2020, as it added 1.01 million subscribers, down from 1.06 million in October and 1.33 million in September. However, this was higher than the average monthly addition of nearly 700,000 in 2019-20.

According to provisional payroll data, about 641,000 new members joined EPFO in November while nearly 370,000 members exited and then rejoined the retirement fund organisation. The total net new subscribers added to EPFO in the current fiscal till November stood at 4.529 million.

subscribers within establishments covered by EPFO and subscribers choosing to retain membership by transferring funds rather than opting for final settlement," said the EPFO. "The rejoining of exited members indicates workers are returning to jobs with decline in active Covid-19 cases in India." Age-wise analysis of the data indicates that those in the 22-25 year age bracket registered the highest growth in subscriber base, with about 272,000

net enrolments in November. This was followed by about 221,000 net enrolments in the 18-21 years age bracket.

"The 18-25 age-group members can be considered as fresh hands in the labour market and have contributed roughly 48.72% of the new subscriber additions for November, 2020," the EPFO said in a statement.

Women's share in new enrolment increased to 22.40% in November, with about 143,000 females joining the workforce, from 21.64% in October.

Maharashtra, Haryana, Gujarat, Tamil Nadu and Karnataka remained at the forefront of the employment recovery cycle, accounting for about 53% of the total net payroll addition between April and November 2020 across age groups, showed the EPFO data.

Category-wise analysis of industry showed that 'expert services' category (which primarily includes manpower agencies, private security agencies and small contractors) continued to be the best performer by contributing a combined payroll of 2.345 million in the first eight months of this fiscal.

Power Demand Touches All-time High of 185 GW

New Delhi: All-India power demand on Wednesday morning touched a record high of 185.82 gigawatts (GW), said Power Secretary S N Sahai. "Power demand continues to surge. Yet another record - all India demand: 185.82 GW ie 185,822 MW at 09:35hrs today ie 20/01/21. It has crossed previous all India demand of 182.89 GW i.e. 182,888 MW on 30th December, 2020", Sahai said in a tweet. On December 30, 2020, all-India

power demand had touched 182.89 GW. According to data from the power ministry, the peak power demand met (the highest supply in a day) during January last year stood at 170.97 GW.

The rising power demand shows perk up in economic activities leading to higher commercial and industrial demand which was hit due to the pandemic. The government had imposed a nationwide lockdown on March 25, 2020 to curb Covid-19.
