Sub: Reclassification as Public from Promoter and Promoter Group to Shareholder of the Company

My husband, Mr. Ronojoy Mazumdar was the erstwhile Managing Director and Promoter of the Company. He had suffered a major brain stoke in February 2014 and for reasons of mental incapacity due to ill health, he ceased to be a Director of the Company with effect from April 01, 2014. He expired on July 20th, 2023, copy of Death Certificate enclosed. My Brother-in-Law, Late Mr. Sujoy Mazumdar who was a shareholder of the company, also expired on November 28th, 2019, copy of Death Certificate enclosed. I am also a shareholder of the Company.

We are collectively holding in total 1,25,706 shares in the Company and consists of the Promoter Group.

Upon his demise, I request you to kindly reclassify my holding as Public from Promoter Group as I am a 75-year-old housewife and have never contributed in the affairs of the Company nor am I able to do so.

I hereby declare as follows:

- 1. I, along with persons related to me together:
 - (a) do not hold more than ten percent (10%) of the total voting rights in the Company.

(b) do not exercise control over the affairs of the Company, directly or indirectly.

(c) do not have any special rights with respect to the Company through formal or informal arrangements including through any shareholder agreements.

(d) are not being represented on the Board of Directors (including not having a Nominee Director) of the Company.

(e) do not act as a key managerial person of the Company.

(f) are not 'wilful defaulter(s)' as per the Reserve Bank of India guidelines.

- (g) are not fugitive economic offenders.
- 2. There are no pending regulatory actions against me.
- 3. I shall continue to comply with the conditions mentioned at sub-clause (i) (ii) and (iii) of clause (b) of Regulation 31A (3) of SEBI (Listing Obligation and Disclosure Requirements), Regulations 2015 at all times from the date of reclassification, failing which, I shall be reclassified as Promoter/Person belonging to the Promoter Group of the Company.
- 4. I shall comply with the conditions mentioned in the sub-clause (iv) and (v) of clause (b) of Regulation 31A (3) of SEBI (Listing Obligation and Disclosure Requirements), Regulations, 2015 for a period not less than three years from the date of reclassification, failing which, I shall be reclassified as Promoter/Person belonging to the Promoter Group of the Company.

I once again reiterate that my request for reclassification as Public from Promoter/ Promoter Group Shareholder of the Company shall be considered favourably for reasons stated herein.
