The Eligible Shareholders are requested to note the following paragraph should be read in continuation with paragraph 20.12 on page no. 30 of the LOF dated March 8, 2019:

"In the event Seller Member(s) are not registered with the Designated Stock Exchange (i.e. BSE) or if the Eligible Shareholders do not have any stock broker then that Eligible Shareholders can approach any stock broker registered with the BSE (with whom they do not have an account) and can make a bid by using quick unique client code ("UCC") facility through that stock broker registered with the BSE after submitting the details as may be required by the stock broker to be in compliance with the Buyback Regulations. In case Eligible Shareholders are not able to bid using quick UCC facility through any other stock broker registered with the BSE, then the Eligible Shareholders may approach Company's Broker, to bid by using quick UCC facility after submitting requisite documents"

Except as detailed above, all other information and terms of the Buyback as disclosed in the LOF remain unchanged. This Addendum is will be available on the SEBI's website www.sebi.gov.in.
