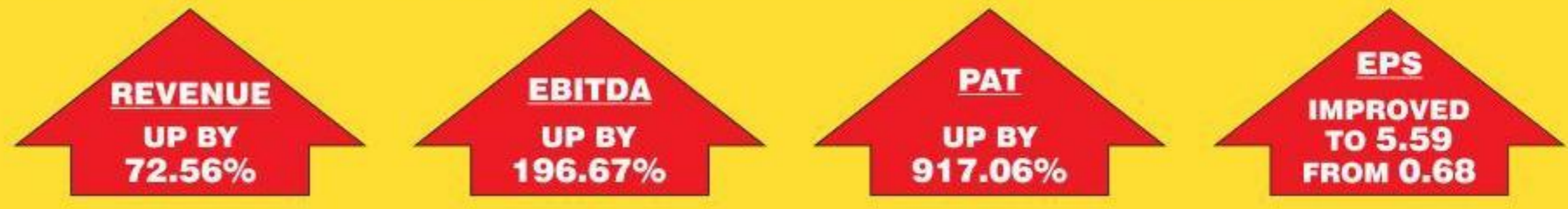

- The above Statement of Unaudited Financial Results ("Financial Results") for the quarter ended 30 June 2022, have been reviewed by the Audit Committee and approved by the Board of Directors at their respective meetings held on 10 August 2022. The Statutory Auditors of the Company have carried out a limited review of these Financial Results. These Financial Results are prepared and published in accordance with Regulation 33 of the SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015, as amended.
  - These financial results are prepared in accordance with the Indian Accounting Standards 34 'Interim Financial Reporting' (Ind AS - 34), as prescribed under Section 133 of the Companies Act, 2013, ("the Act") read with the relevant Rules issued thereunder and other accounting principles generally accepted in India.
  - The figures for the quarter ended 31 March 2022, as reported in these Financial Results are the balancing figures between audited figures in respect of the full financial year ended 31 March 2022 and the published year to date figures up to the end of the third quarter of the previous financial year which were subjected to a limited review.
  - The Company has during the current quarter entered into a Memorandum of Understanding for the sale of its Wind Power Undertaking as a going concern on a slump sale basis for an aggregate consideration of ₹4,800 lakhs which has been fully received by the Company. The agreement for sale is in the process of being finalized.
  - During the current quarter, the Company has, based on technical evaluation, past trends and experience, re-visited the useful life of goods transport vehicles and based such evaluation, revised the useful life of goods transport vehicles from 8.84 years to 15 years. This revision has resulted in a reduction of Depreciation and Amortisation expense by ₹931.07 lakhs for the quarter ended 30 June 2022.
  - Previous period figures have been regrouped / restated wherever considered necessary to conform to the current period classification.

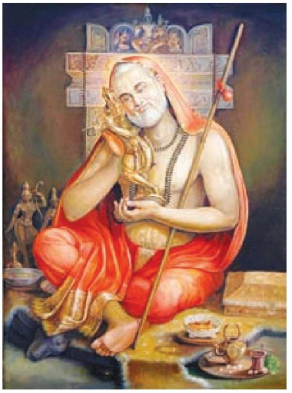
