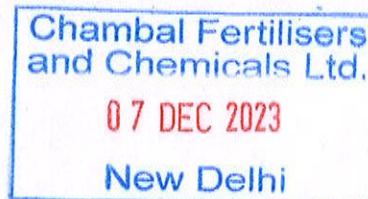

With reference to our email dated 25-11-2023 and your reply throw email dated 28-11-2023 in which I have been instructed to send a physical application, I am sending this application in this regard.

I hold 200 shares of Chambal Fertilizers Ltd, Folio No. 0219099, Certificate No. 1678728 and 1678729 of rupees 100 each dated 23 September 1993, under my wife Manju Chauhan's Name.

I opened a Demat account (A/c - 03252679) in Satna (M.P) office of Karvy with depositing Rs. 5,000 for operating transactions of shares. I also submitted attached original share certificates on 30th November 2018 for converting them to Electronic Form in the Satna office. Later on, when I inquired in the Satna office, it was informed that the certificates have not been converted in electronic form. Karvy's person in Satna office Mr Amit Kushwaha said that your original share certificates have already been sent in 2018 to our Hyderabad office for converting the same to electronic form. But, till date neither of my share certificates have been returned or converted in electronic form. Also, I have not got any response from KARVY'S both Satna and Hyderabad office even after 3 years of continuous follow ups at Satna (M.P) office.

I had raised a complaint to KARVY on 6.06.2021 and on Mar 7, 2021 but had gotten no response. I am writing this to you for issuing duplicate share certificates as my original share certificates has been taken by KARVY for converting them in electronic form but my 200 share have been lost by KARVY and gave no response.

As the transaction by Karvy has been banned, kindly issue my attached duplicate share certificates so that the same may be converted to electronic form by the new agency.

Hoping for your kind reply and proper action to avoid my inconvenience and loss. Scanned copy of share certificates is also being attached.

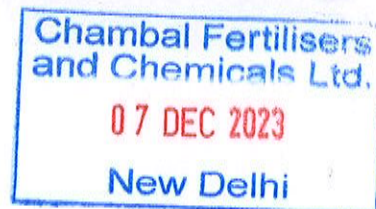
