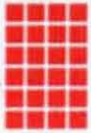

## Gist of the Proceedings of the 3<sup>rd</sup> Annual General Meeting

The 3<sup>rd</sup> Annual General Meeting (AGM) of the Members of Poojawestern Metaliks Limited was convened at 11.00 a.m. on Monday, September 30, 2019 at the registered office of the company and concluded at 12.30p.m.

Chairman informed members that registers and documents as required by law are open for inspection of members. Then after, Chairman delivered his speech about brief of the Company's business which included current and future prospectus of the Company.

The Chairman invited the members to express the views and to seek clarification/ask questions, if any on the items of business as per the Notice of AGM, Thereafter the chairman guided members to cast their votes on each resolution for following agenda items:

1. Adoption of Financial Statements.
2. Appointment of Director in place of Director retiring by Rotations.

Post the question and answer session, the Chairman put before the members the businesses mentioned in the notice of AGM for their approval.

The Chairman thanked the members present at the meeting and then concluded the meeting by authorizing the representative of practicing company secretary (Scrutinizer) to carry out the poll process and declare the voting results. He informed the members that the result of poll will be made available on the website of the company within 48 hours of the conclusion of the meeting.
