3 youths barge into shop, open fire, demand ₹50 crore

REWARI: Three youths on Tuesday barged into a sanitary hardware shop in Bawal town of Haryana's Rewari and opened fire in the air, demanding Rs50 crore from the shop owner, police said. The trio reached businessman Rahu Batra's shop at Chhoturam Chowk in the town on a Pulsar and fled the scene after damaging the glass door with their gunshot, leaving businessmen shocked at the broad daylight extortion bid, the police said. An FIR was lodged at Batra's complaint and police have launched a manhunt. In his complaint, Bartra said as the trio entered his shop, he asked them to sit and offered water, thinking that they may be customers.

MP man detained for cutting sadhu's hair, abusing him

KHANDWA: A man has been detained for allegedly cutting the hair of a sadhu in Khandwa in Madhya Pradesh, a video of which was being circulated on social media. The incident occurred in Patajan village in Khalwa block, some 70 kilometres from the district headquarters on Sunday, and a probe began after the video went viral on Monday, an official said. "The incident took place at 1 pm on Sunday. The accused, identified as Praveen Gaur, who is the son of a hotelier, has been detained," Superintendent of Police Vivek Singh said on Tuesday.

7 killed in 2 Assam road accidents

GUWAHATI: At least 7 people were killed and several others injured in two separate road accidents in Assam on Tuesday, officials said. Police said at least 5 people were crushed to death while 3 others were injured after a speeding truck hit them in Darrang, while 2 were killed and several others were injured at Hatibondha in Kaliabor in Nagaon. Police said the Darrang accident took place at Sipajhar College Chowk area on National Highway-15 while the victims were out on a morning walk. According to police, the truck lost control and ran over the pedestrians before hitting a tree. Both its driver and helper fled the spot. In Nagaon, the accident occurred when an autorickshaw and a goods carrier collided head-on.

6 KILLED IN ROAD ACCIDENT IN JIND: A vehicle collided head-on with a truck near Kandela village in Haryana's Jind district on Tuesday morning, leaving six dead and 17 injured, police said. The victims, all residents of Hisar, were returning from Haridwar after performing rituals following the death of an elderly family member. The injured have been referred to nearby hospitals, police said, adding that two of them were in a serious condition. The truck driver fled from the accident spot.

NEW DELHI: The SC on Tuesday allowed daughters of an 89-year-old woman, who is suffering from advanced dementia, to take care of their mother despite the eldest son refuting the allegation of her ill-treatment and saying he is being "painted as a black sheep". A vacation bench of Justices DY Chandrachud and Bela M Trivedi noted that the two daughters are willing and undertake to take care including the hospital care of their mother, who is at present in the custody of their eldest brother. Meanwhile, the SC set aside Delhi HC order granting bail to an accused in a kidnapping-cum-murder case of a boy, 13, whose body was found in a drain in East Delhi in November 2014.
