# Deepak, Nishant make cut for Paris Olympics in world boxing qualification

**New Delhi:** World Championships bronze medallists Deepak Bhoria and Nishant Dev will be among nine Indian boxers in the running to seal Paris Olympic quotas at the first qualification tournament,

scheduled to take place in Busto Arsizio, Italy from February 29 to March 12. Shiva Thapa (63.5kg) and Jaisime Lamoria (60kg) were also named in the nine-member Indian squad.

### Davis Cup team begins preparation

**New Delhi:** Braving cold conditions, the Indian Davis Cup team began its preparatory camp for the upcoming grass court tie against Pakistan, keen to find a second singles player in the absence of top-ranked Indian Sumit Nagal. Country's top singles players -- Nagal (ranked 137) and Sasikumar Mukund (ranked 463) -- have pulled out of the tie February 3-4 tie in Islamabad. Their absence means that Ramkumar Ramanathan is the only singles specialist player in the team. Captain Rohit Rajpal has to choose between Yuki Bhambri and N Sriram Balaji to play the second singles.

### Punnin upsets top seed Jessie

**Pune:** Thailand's Punnin Kovapitukted upset top seed Jessie Aeny of USA 6-4, 6-1 to enter the main draw at 22nd edition of NECC Deccan ITF 50K Women's Tennis Tournament being organized by Deccan Gymkhana and sponsored by National Egg Coordination Committee (NECC) under the auspices of the ITF, AITA and MSLTA and played at the Deccan Gymkhana Tennis Courts. Both the Indian girls Humera Bahamus and Zeel Desai could not keep their momentum and went down with contrasting scores. Fourth seed Naho Sato of Japan outthit Humera Bahamus 6-3, 6-1, while eighth seed Viktoria Morvayova of Slovakia gets past Zeel Desai 3-6, 6-4, 6-4.

### Prannoy to lead Indian charge

**Jakarta:** Singles ace HS Prannoy will spearhead the Indian challenge at the Indonesian Masters Super 500 badminton tournament beginning here on Tuesday after the pull-out of crack doubles pair of Satwiksairaj Rankireddy and Chirag Shetty. Having finished runners-up in back-to-back tournaments of Malaysia Super 1000 and India Open Super 750, the reigning Asian Games champions have given the tournament a miss with an eye on their workload with a gruelling season ahead of them. The duo's absence may have taken some sheen of the tournament, but world No. 9 Prannoy will look to keep the Indian flag high continuing his consistent run.

### Wild cards for rising Indian stars

**Mapusa:** Former bronze medallist in World Youth Championships (U-19), Payas Jain, Asian Games 2022 men's doubles quarterfinalist Manush Shah, and 37th National Games champion Archana Kamath are among the eight Indian paddlers who received wildcard entries in the singles main draw of the World Table Tennis (WTT) Star Contender Goa 2024, set to start at the Peddem Indoor Stadium here on Tuesday. In addition to Payas, Manush and Archana, former World No. 1 in U-19 girls' doubles Suhana Saini and Snehit Suravajjula are the other two Indian players who have also been handed host wildcards at the second edition of India's biggest international table tennis tournament.

### State gymnast Davande wins gold

**Chennai:** Defending champions Maharashtra opened their gold medal account at the Khelo India Youth Games 2023 on Monday when gymnast Aaryan Davande clinched the Artistic All-Round crown at the SDAT Aquatics complex here. Davande accumulated a total of 73.200 points to pip Uttar Pradesh's Pranav Mishra (72.470 pts) to the top spot. Harshit of UP clinched the bronze with a score of 71.700 points in the event where the boys have to perform on six different apparatus to decide the winner.

### Indian hockey team win over France

**Cape Town:** Skipper Harmanpreet scored a brace as Indian men's hockey team thrashed France 4-0 to begin its campaign in the Four-Nation Tournament on a rousing note here on Monday. Harmanpreet (13th, 26th minutes) converted two penalty corners while Lalit Upadhyay (42nd) and vice-captain Hardik Singh (49) were the other goal-getters for India.

Real Madrid needed help from VAR - a lot of help - to avoid an embarrassing setback at home against last-place Almeria in the Spanish league on Sunday.

Madrid got three favourable video reviews in the second half, then scored a winner nine minutes into stoppage time to rally to a 3-2 win over Almeria, the only team yet to win in the league this season.

The dramatic late win moved Madrid two points in front of Girona, which hosts relegation-threatened Sevilla later Sunday.

Barcelona moved back into third place with a 4-2 win over Real Betis, with substitute João Félix breaking the deadlock in the 90th minute and Ferran Torres completing his hat trick in stoppage time. The Catalan club remains seven points behind Madrid.

Dani Carvajal scored Madrid's winner from close range after a cross into the area, erupting the crowd at the Santiago Bernabeu Stadium and sending the Almeria players into despair.

The goal came after three separate VAR decisions allowed Madrid to stay in the game after trailing 2-0 in the

## REVIVING GLORY

### Premier Badminton League awaits a comeback on the sporting calendar

Dormant for the past three years following the disruption caused by the COVID-19 pandemic, the Premier Badminton League could see a revival by the end of this year or early 2025, the national federation's secretary Sanjay Mishra revealed.

Mishra said efforts are on by the Badminton Association of India (BAI) to resolve some internal issues which were coming in the way of bringing the event back on the calendar.

"Badminton league is important for our players. Unfortunately, it hasn't been conducted since the 2020 pandemic. There were also some internal issues but those would be solved soon," Mishra said, without elaborating any further.

"We have spoken to the organisers and asked them to get back in a month or two. So I am hopeful that by the end of this year or early next year, we should be able to host the event," he asserted.

PBL, organised by SportzLive, had emerged as one of the world's top badminton leagues with stars like Olympic champions Carolina Marin and Viktor Axelsen, Tokyo Games silver-medallist Tai Tzu-Ying and former World No. 1 Lee Chong Wei, participating in the last five editions.

But after the 2020 edition, which was conducted just before the outbreak of COVID-19, the league couldn't be held. The BAI tried to organise it in December-January of 2022-23 but it didn't materialise.

"...there was a second wave (of COVID-19) in 2021 and this led to a financial crunch. But we are trying to raise funds and there are a few investors who are interested," said Prasad Mangipudi, Co-founder of Sportzlive and PBL.

## Matunga Gym snatch narrow victory
