Punjab: 5 arrested after another explosion near Golden Temple

Five persons were arrested on Thursday in connection with the low-intensity blast incidents near the Golden Temple here, hours after another explosion took place in the area, police said.

In less than a week, three explosions have taken place in the city. The third explosion occurred on Wednesday midnight in Galiara, the pathway and park around the Golden Temple, behind Guru Ramdas Ji Niwas (inn) building, police said. A lowintensity explosion had taken place on a heritage street near the shrine on May 6. The second one occurred in the area in less

than 30 hours after the first blast. investigation team will be formed to further investigate the matter, said Punjab Director General of Police (DGP) Gauary Yaday while addressing the media here.

The motive behind the explosions is yet to be ascertained, Yadav said, adding whether the arrested five persons were a selfradicalized module or worked at the direction of some other persons will also be investigated. Haryana CM announces monthly assistance for patients suffering from rare diseases

CHANDIGARH, MAY 11 / --/ Haryana chief minister Manohar Lal Khattar on Thursday announced a monthly assistance of Rs 2,750 for patients suffering from 55 rare diseases, benefitting close to 8,000 people.

Khattar was taking part in a state-level programme in Yamunanagar during which he inaugurated 46 health institutions in 17 districts. During the programme, he announced the monthly assistance of Rs 2,750 for patients suffering from 55 rare illnesses such as Pompe Duchenne disease. muscular dystrophy and spinal muscular atrophy, according to a statement issued here. The state government already provides pension benefits to patients suffering from thalassemia, hemophilia, and Stage-III and Stage-IV cancer. The latest announcement adds 55 rare diseases to the list with the government making a budget provision of Rs 25 crore for the puroise, according to the statement. Around 8,000 patients will be able to get the financial benefit, the statement added.

Sharing government data on such patients, Khattar said 3,000 people suffering from thalassemia hemophilia, 4,000 have Stage-III and Stage-IV cancer and about 1,000 suffer from 55 other rare diseases, who will now eceive the pension. inaugurations and the also being increased," he assistance financial announced for the patients will certainly play a pivotal further strengthening the health infrastructure along with providing the best health care facilities to every citizen," Khattar said. During the programme, the chief minister inaugurated the 275-bed Mukand Lal District Civil Hospital in Yamunanagar, constructed at a cost of Rs 100 crore. The minister chief inaugurated health institutions in Bhiwani. Karnal, Fatehabad, Rohtak, Kaithal, Faridabad, Palwal, Sirsa, Panchkula, Nuh, Charkhi Dadri, Jind, Hisar. A metallic tiffin box was also filled with the same explosive material.

Chhattisgarh CM says ED trying to implicate him in alleged liquor scam

RAIPUR, MAY 11 /--/ Chhattisgarh chief minister Bhupesh Baghel Thursday accused the **Enforcement Directorate** (ED) of trying to implicate him in the alleged liquor scam in the state.

The ED has been acting as an agent of the Bharatiya Janata Party, Baghel claimed while talking to reporters at the Police Lines helipad in Raipur. "Our claim that the ED has been acting as an agent of the BJP has proved right. The way it has been threatening people to implicate them in false cases, they are now trying to implicate me in the alleged excise scam. Their main aim is to defame the Congress government," he said. The BJP has failed to take on the Congress government, soit is misusing the ED as its 'subordinate organisation," the chief minister claimed. The chief minister asked why the ED was not taking action against distillers if they had accepted that they were selling liquor without paying the excise duty. The way things have surfaced in the media trial, action should have been taken against them (distillers) but instead of them, others are being arrested, Baghel said. "It clearly shows there is a nexus between the ED and distillers or between the BJP and distillers..it seems the BJP is trying to save distillers. The state's Anti-Corruption Bureau will take cognisance of it and act

accordingly," he said. The chief minister further said his government has been discussing the issue with legal experts as "scheduled" offences like extortion and corruption in the state do not come under the ED's jurisdiction. "The ED has been acting like local police in the state which is against the spirit of federal structure. Our legal experts have informed us that the investigation into scheduled offences like extortion and corruption does not come under the ED's jurisdiction. We have been discussing with legal experts all illegal actions taken by the ED officials and will soon take action against it," Baghel stated. The ED had in a statement said a "massive scam" happened in liquor trade in Chhattisgarh by a

syndicate, comprising highlevel state government officials, private persons and political executives, that generated corruption money of more than Rs 2,000 crore. Two persons, including Congress leader and Raipur Mayor Aijaz Dhebar's brother Anwar Dhebar, were arrested in the alleged liquor scam case recently.

The ED has made two

fresh arrests of a hotel trader and liquor businessman in the Rs 2,000 crore alleged liquor syndicate scam, official sources said Thursday. Nitesh Purohit, promoter of Giriraj hotel located in state capital Raipur, was arrested on Wednesday noon while Pappu Dhillon was arrested on Thursday, they said. The agency told the court on Wednesday that Purohit was allegedly "aware of the illegal operations of Anwar Dhebar and willingly assisted him in movement of proceeds of crime to Anil Tuteja (an IAS officer of Chhattisgarh cadre)" and another person. Dhebar was also produced by the agency before a special Prevention of Money Laundering Act (PMLA) court in Raipur on Wednesday at the end of his four-day remand period, and the court later extended his custody by five more days. the sources said. (PTI)

G20 meeting in Srinagar: Security stepped up in Jammu, in-person classes suspended in some schools

JAMMU. MAY 11 /--/ Ahead of a G20 security of Army, Border Security Force, meeting in Srinagar, security has been tightened in Jammu region, particularly in border districts, and more than 10 Army schools have been closed as part of precautionary measures.

The security agencies have identified infiltration routes and stepped up security to prevent any infiltration from across the border, officials said on Thursday. The third G20 Tourism Working Group Meeting will be held at the Sher-i-Kashmir International Conference Centre (SKICC) on the banks of the Dal lake in Srinagar from May 22 to 24. Security has been heightened in Jammu, particularly in border districts, and around vital Army and security establishments, the officials said. Multi-tier

police and Central Reserve Police Force besides Village Defence Committees has been activated along the International Border (IB) and the Line of Control (LoC), they said. Security and checkpoints have also been strengthened along the Jammu-Pathankot highway, all vehicles are being checked and all movements are being monitored, they added. In view of the threat perception, the officials said, more than 10 Army and other schools on the highway and in border districts of Rajouri and Poonch have been closed and online classes will be conducted for students till May 25. In an advisory, police urged people to remain alert and check their vehicles before starting them. (PTI)
