**Sub: Grant of Stock Options under Employee Stock Options Scheme - 2022 ( "ESOS 2022" )**

**Ref: Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015**

We wish to inform you that, pursuant to the above said Regulation and subject to the provisions of SEBI (Share Based Employee Benefits and Sweat Equity) Regulations, 2021 {SEBI (SBEB & SE) Regulations, 2021} and approval granted by the Members on 10<sup>th</sup> August 2022, the Nomination and Remuneration Committee of the Board of Directors in its meeting held today, had approved the grant of 1,50,000 stock options under ESOS 2022.

The terms of the grant, inter-alia, are as under:

3.	Total number of shares covered by these Options	1,50,000 Equity Shares of face value Rs. 10/- each (Each Option is convertible into one Equity Share of the Company).
4.	Pricing Formula	Under this Scheme, the Exercise Price will be decided by the Nomination and Remuneration Committee on the basis of Market Price.  However, the Exercise Price shall not be less than the par value of the Equity Shares of the Company.  Accordingly, the exercise prices are at a discount to the market price and determined at Rs. 10/- per Option for 75,000 Options and Rs.160/- per Option for 75,000 Options.  Market Price is determined on the basis of closing price of the Company's shares in the National Stock Exchange of India Limited on August 04, 2023.
5.	Options Vested	Not Applicable, as this outcome is pertaining to grant of Options under the Scheme.  <b><u>Vesting Period:</u></b> All the Options granted above would vest over a period of 3 years with a vesting schedule of 40% at the end of 1 <sup>st</sup> year from date of grant and 7.5% for each quarter for the next 2 years, aggregating to 30% each at the end of 2 <sup>nd</sup> year and 3 <sup>rd</sup> year.
6.	Time within which Option may be exercised	All Options upon vesting shall be exercisable within 10 (Ten) years from the Vesting of the last tranche of the granted Options subject to being in the employment of the Company.
