The Company has on Thursday, November 9, 2023, completed dispatch of the Notice seeking approval of the Members whose names appear in the Register of Members / list of Beneficial Owners as received from Depository Participants ('DPs') and TSR Consultants Private Limited, the Company's Registrar & Share Transfer Agent ('Registrar'/RTA) and whose e-mail addresses are available with the Company as on Friday, November 3, 2023 ('Cut-off date'). Accordingly, a physical copy of the Notice along with Postal Ballot form and prepaid business reply envelope, have not been sent to the Members for this postal ballot.

The Company has engaged the services of National Securities Depository Limited ('NSDL') for providing remote e-voting facilities to the NSDL Members, enabling to cast their vote electronically and in a secure manner. The remote e-voting period commences on Monday, November 13, 2023, (9:00 a.m. IST) and ends on Tuesday, December 12, 2023 at (5:00 p.m. IST). The remote e-voting facility shall be disabled by NSDL thereafter and Members will not be allowed beyond the said date and time. Members are requested to record their Assent (FOR) or Dissent (AGAINST) through the remote e-voting process not later than 5:00 p.m. (IST) on Tuesday, December 12, 2023. During this period, Members of the Company holding shares either in physical or electronic form as on the Cut-off date shall cast their vote electronically. The voting rights of the Members shall be in proportion to their share of the paid-up Equity share capital of the Company as on the Cut-Off Date. Once the vote on the Resolution is cast by a Member, the Member shall not be allowed to change it subsequently. Only those Members whose name are recorded in the Register of Members of the Company or in the Register of Beneficial owners maintained by DP as on the cut-off date will be entitled to cast their votes by remote e-Voting.

The Scheme was filed by the Company with the Hon'ble National Company Law Tribunal, Mumbai Bench (NCLT) on 27th September, 2023 and is pending with the NCLT.
The scheme is, inter alia, subject to receipt of the statutory and regulatory approvals, including approvals from stock exchange, NCLT and the shareholders and creditors of the Companies involved in the Scheme and the Company is in the process of seeking the same.

ओबीसी यादीत आणखी जातींच्या समावेशाची शिफारस

आधी परस्पर निर्णय, आता राज्य मागासवर्ग आयोगाकडे प्रस्ताव राजेश्वर ठाकरे, लोकसत्ता



नागपूर : राज्य सरकारने राज्य मागासवर्ग आयोगाच्या शिफारशीशिवाय काही नव्या जाती, पोटजातींना ओबीसी यादीत समाविष्ट केले असून, त्यांचा केंद्राच्या यादीत समावेश करण्यासाठी प्रयत्न सुरू आहेत. मात्र, राष्ट्रीय मागासवर्ग आयोग अनुकूल नसल्याने सरकारला राज्य मागासवर्ग आयोगाकडे धाव घ्यावी लागली आहे.

राज्य सरकारने अलीकडे लोधा, लोधी, बडगुजर, वीरशैव लिंगायत, सलमानी, भोयर पोवार, सूर्यवंशी गुर्जर, बेलदार, झाडे, डांगरी आणि परमार अशा काही नव्या जाती आणि पोटजातींचा समावेश ओबीसी यादीत केला. त्यांचा समावेश केंद्राच्या यादीतही करण्यासाठी हालचाली सुरू आहेत. या प्रस्तावावर चर्चा करण्यासाठी राष्ट्रीय मागासवर्ग आयोगाचे अध्यक्ष हंसराज अहिर यांनी मुंबईत बैठक घेतली. त्यात

ओबीसी यादीत नव्याने समाविष्ट केलेल्या जातींचा समावेश केंद्राच्या यादीत करण्याबाबत राष्ट्रीय मागासवर्ग आयोगाबरोबर जुक्तचित बैठक झाली. अद्याप त्यावर तोडगा निघालेला नाही. - अतुल सावे, मंत्री, इतर मागासवर्ग बहुजन कल्याण.

राज्य मागासवर्ग आयोगाने शिफारस केलेल्या बेलदार, डांगरी, भोयर पवार या जातींचा केंद्राच्या यादीत समाविष्ट करण्याबाबत अनुकूलता दर्शवण्यात आली. मात्र, उर्वरित जातींचा समावेश राज्याने आपल्या यादीत केल्याने त्यास अर्थ काय, अशी विचारणा आयोगाने केली. केंद्राच्या यादीत समावेशासाठी प्रथम राज्य मागासवर्ग आयोगाच्या शिफारशीची आवश्यकता असते, अशी माहिती राज्य मागासवर्ग आयोगाचे सदस्य न्या. नागपूर : राज्य सरकारने प्रत्येक समाजाची सामाजिक आणि आर्थिक परिस्थिती पाहून संबंधित समाजातील विद्यार्थ्यांसाठी बार्टी, सारथी, महाज्योती, टीआरटीआय या संस्थांच्या माध्यमातून विविध प्रशिक्षण कार्यक्रम, योजनांची आखणी केली. मात्र, आता सर्व संस्थांसाठी 'समान धोरण' निश्चित करण्याच्या नावाखाली संस्थांच्या स्वायत्ततेवर घाला घालून लाभार्थी संख्या कमी करण्याचा प्रयत्न सुरू असल्याचे समोर आले आहे.

सर्वच संस्थांच्या लाभार्थीची संख्या घटणार असल्याने या शासन निर्णयाविरोधात रोष वाढत आहे. संस्थांच्या स्वायत्ततेवर सरकारकडून वारंवार आघात केला जात असल्याचा आरोप युवा ग्रॅज्युएट फोरमचे संस्थापक अतुल खोब्रागडे यांनी केला. ओबीसी, व्हीजीएनटी विद्यार्थ्यांची संख्या सर्वाधिक असतानाही केवळ २०० विद्यार्थ्यांना अधिछात्रवृत्ती देण्याचा निर्णय घेण्यात आल्याबद्दल स्टुडेंट राइट्स असोसिएशन ऑफ इंडियाचे उमेश कोरम यांनी नाराजी व्यक्त केली. समाजघटकांची आर्थिक, सामाजिक स्थिती वेगवेगळी असताना सर्वांना एकच नियम कसा लावता येईल, असा सवाल स्टुडेंट हेल्पिंग हॅन्डचे कुलदीप आंबेकर यांनी केला. तर सर्व संस्थांना समान संधी मिळावी, या भावनेतून मुख्यमंत्र्यांनी ही योजना आखल्याचे बहुजन कल्याण मंत्री अतुल सावे यांनी स्पष्ट केले.
