"Sunak invites strong opinions. One-third of voters think he would be good in the top job, one third do not. But in an unpopular field where every other candidate is in net-negative territory, this score draw makes him the public's favourite. He is particularly

popular with the all-important 2019 Conservative voter, as the only candidate to have half approve of him," he said.

An MRP model, which maps survey results onto every seat in the country, found that, among all voters, Sunak had the highest net approval score in 76 per cent of the seats won by the Tories in the last general election over two years ago, compared to 19 per cent in which Tugendhat came out

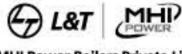
