An MRP model, which maps survey results onto every seat in the country, found that, among all voters, Sunak had the highest net approval score in 76 per cent of the seats won by the Tories in the last general election over two years ago, compared to 19 per cent in which Tugendhat came out

Among all voters, the most popular policy priority was to "turn the economy around", with addressing the National Health Service (NHS) backlog and restoring trust and integrity in public life coming second and third respectively. Cutting taxes, which has emerged as a central focus of all the debates so far, was the fourth priority, selected by 38 per cent of voters overall and 40 per cent of Conservative voters.

FIRES SCORCH FRANCE, SPAIN; TEMP-RELATED DEATHS SOAR

Paris Firefighters struggled on Sunday to contain wildfires raging out of control in France and Spain as Europe wilts under an unusually extreme heat wave that authorities in Madrid link to a rise in excess mortality.

The scorching temperatures have reached as far north as Britain, where its weather agency has issued its first-ever "red warning" of extreme heat for Monday and Tuesday when temperatures in southern England may reach 40 degrees Celsius for the first time. Two huge blazes that have been consuming pine forests for six days just south of the city of Bordeaux in southwest France have forced the evacuation of some 14,000 people, including many who were set to spend their vacation at campsites.

Iberian Peninsula have made it particularly susceptible to wildfires, some caused by lightning, others by accident, and even some intentionally set, after a mass of hot air was blown up from Africa last week.

So far, there have been no fire-related deaths in France or Spain. In Portugal, a pilot of a firefighting plane died when his aircraft crashed on Friday. But as temperatures remain unusually high, heat-related deaths have soared amid a heat wave that the EU considers the work of climate change. In Spain the

second heat wave of the summer has kept highs above 40 degrees Celsius in many areas, hitting peaks of 43 degrees Celsius regularly. According to Spain's Carlos III Institute, which records temperature-related fatalities daily, 300 deaths were attributed to high temperatures from July 10-15. That was compared with 27 temperature-related deaths the previous six days. In France, the fire in La Teste-de-Buch near the Atlantic coast has forced 10,000 people to flee the area popular for the Arcachon seaside resort.

'Those people': French minister's LGBTQ remarks spark anger

Paris Pressure is mounting on a French government minister to quit over comments stigmatising homosexuality and LGBTQ people, in the latest challenge to President Emmanuel Macron's leadership. Caroline Cayeux's remarks have hurt and angered many - including her colleagues - and prompted broader discussion around persistent discriminatory attitudes by people in power.

medalist, doctors, artists, an ex-prime minister, a former top Macron adviser and others from within Macron's centrist political camp. Cayeux, the minister for regional relations, was asked in an interview this week about her opposition to France's 2013 law authorising gay marriage and adoption, and comments at the time saying they were "against nature." Speaking Tuesday to broadcaster Public Senat, she said she was being wrongly painted as prejudiced. "I maintain my remarks. I always said that if the law were voted, I would apply it," she said. "I have a lot of

friends among all those people, and I'm being targeted by an unfair trial. This upsets me." The remarks set off shockwaves among LGBTQ people and provoked calls for her resignation. A legal complaint was filed against her for public insult. Cayeux then tweeted her regrets, saying her words were "inappropriate," and sent a letter to anti-discrimination groups to apologize. She told newspaper Le Parisien that the comments "do not at all reflect my views." Many questioned the sincerity of her change of heart, and say the damage has been done.

Russia strikes south Ukraine city, presses attacks in east

Vynnytsia Russian missiles hit industrial facilities at a strategic city in southern Ukraine on Sunday as a funeral was held for a four-year-old girl killed in an earlier deadly strike elsewhere in the country. Liza, who had Down syndrome, was en route to see a speech therapist with her mother when a Russian missile struck the city of Vynnytsia in central Ukraine on Thursday. At least 24 people were killed, including Liza and two boys aged 7 and 8.

More than 200 others were wounded, including Liza's mother, who remains in an intensive care unit in grave condition. On Sunday, more Russian missiles struck industrial facilities in the strategic southern city of Mykolaiv, a key shipbuilding center in the estuary of the Southern Bug river. There was no immediate information about casualties. Mykolaiv has faced regular Russian missile strikes in recent weeks as the Russians have sought to soften Ukrainian defenses.
