1. I, along with the person related to me ( as defined under sub-clauses (ii), (iii) and (iv) of clause (pp) of sub-regulation (1) of regulation 2 of SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018:-
  - a. do not , together, hold more than 10% of the total voting rights in the Company ;
  - b. do not exercise control over the affairs of the Company, directly or indirectly;
  - c. do not have any special rights with respect to the company through formal or informal arrangements including through any shareholder agreements;
  - d. do not represent on the board of directors (including not having a nominee director) of the listed entity;
