Govt sanctions ₹6,540 cr via Agri Infra Fund so far

THE CENTRE HAS approved over 9,000 applications and sanctioned ₹6,540 crore so far, for the development of agriinfra projects, the agriculture minister said on Friday. He said: "As on date, 16,026 applications for an amount of ₹10,627 crore have been received on the AIF portal.Out of these, 9,019 applications for ₹6,540 crore have been sanctioned."

This amount has been sanctioned under the Agriculture Infra Fund (AIF), under which financing facility is provided for investment in viable projects for post-harvest management Infrastructure and community farming assets through interest subvention and support through credit guarantee facility.

Coal India plans bulk exports for first time

COAL INDIA, THE world's largest coal miner, plans to directly export output to neighbouring countries, according to sources and documents seen by *Reuters*, after

decades of exclusively supplying domestic consumers. The staterun company plans to export to Bangladesh, Nepal and Bhutan, according

to a draft policy sent to the secretary of the coal ministry and reviewed by Reuters, as a part of India's "neighbourhood first" policy, which seeks to counter China's growing economic influence in South Asia.

The proposal was presented at an internal board meeting on corporate strategy in October 2020 and was confirmed by Coal India's chairman to Reuters this week, although a critical coal shortage in India now means the first such shipments would be unlikely until the end





Haryana moves SC against stay on law for 75% jobs to locals

FE BUREAU New Delhi, February 4

> THE HARYANA GOVERNMENT on Friday moved the Supreme Court against the Punjab and Haryana High Court's order staying its law providing 75% reservation in private sector jobs to local candidates. A Bench led by Chief Justice NV Ramana

agreed to hear the Manohar Lal Khattargovernment's appeal on Monday after Solicitor General Tushar Mehta sought an urgent hearing, saying the HC passed the order after giving him just 90 seconds to respond.

Ouestioning the validity of Thursday's interim order that suspended operation of the Haryana State Employment of Local Candidates Act, 2020, the state government said that the HC order is "completely in teeth of the law laid down by the SC which unambiguously held that if a legislation which pertains to reform or change should not be stayed at an interim stage".

On January 15, the state had notified the Haryana State



Employment of Local Candidates Act, 2020, that provides reservation for a "local candidate", who has been defined as someone domiciled in the state. It requires every employer to employ 75% local candidates for posts where the gross

monthly salary is not more than ₹30,000 in various private companies, societies, trusts, and partnership firms, etc, and the law is applicable for 10 years.

Stating that the HC's order was ex facie unsustainable and liable to be set aside, the state government in its appeal stated that the stay order was in violation of the principle of natural justice as the HC did not give any opportunity to argue the case. It added that the 2020 Act was in nowayarbitraryorunjust as the law was for a limited period and

required every employer to hire 75% local candidates to such posts where gross salary is less than ₹30,000 per month.

Three industry associations from Gurgaon, Faridabad and Rewari had moved the HC, alleging that the new law went against constitutional provisions and the basic principle of merit underpinning the private sector growth. They said that the law is against the basic principle of meritocracy that acted as the foundation for businesses to grow and remain competitive.

Payment delays: Maha likely to opt out of PMFBY pate in the scheme keeping in

THE MAHARASHTRA GOV-**ERNMENT** is likely to opt out of the Centre's flagship crop insurance scheme — Pradhan Mantri Fasal Bima Yojana (PMFBY) and establish its own crop insur-

ance company, following several

representations from farmers.

Senior agriculture department officials, who were present at a review meet called by state's agriculture minister Dadasaheb Bhuse a couple of days ago, revealed that moves are afoot to get out of the scheme after receiving complaints about delays in payment of claims by insurance companies.

At the meeting, farmers and farm leaders alleged that the assessment of crop damage under the scheme was faulty and farmers have to struggle to get their compensation from insurance firms. This Rabi season, around 12.50 lakh farmers participated in the scheme and normally over 1 crore applica-



tions are received from farmers under the Kharif and Rabi seasons. After listening to representations by farmer organisations, the state's agriculture minister directed officials to study the issue and draft a proposal on these lines. Due to several flaws in the PMFBY, losses incurred during the last two Kharif and Rabi seasons have not been compensated. The insurance companies still owe farmers ₹271 crore in insurance claims for the 2020 season officials said.Insurance claims of ₹2,800 crore for the Kharif 2021 are still being worked out, they said. States and UTs can partici-

PMFBY in one or more seasons. Under PMFBY, premium to be paid by farmers is fixed at 1.5% of the sum insured for rabi crops and 2% for kharif crops, while it is 5% for cash crops. The balance premium is split equally between the Centre and states. Many states have demanded their share of the premium subsidy be capped at 30%. Already, Gujarat, Andhra Pradesh, Telangana, Jharkhand, West Bengal and Bihar have exited PMFBY, citing the cost of the premium subsidy to be borne by them. Madhya Pradesh and Tamil Nadu have adopted the Beed formula in several districts.

Following this, the Centre had written to state governments seeking their views on including the 'Beed formula' as an option under PMFBY. Under the 'Beed formula', also known as the 80-110 plan, the insurer's potential losses are circumscribed – the firm does not have to entertain claims above 110% of the gross premium. The insurer will refund the premium surplus (gross premium minus claims) exceeding 20% of gross premium to the state government.The state government has to bear the cost of any claims above 110% of the premium collected to insulate the insurer from losses, but such higher level of claims rarely occurs, so the states reckon the formula in effect reduces their cost to run the scheme. Bhuse said that the Maharashtra government had written to the Centre seeking the inclusion of the 'Beed formula' but not much happened afterthat.In December last year, the Centre appointed two separate groups of experts to suggest suitable working models with cost benefit analysis that will lower crop insurance premium and technology in yield estimation under PMFBY after the exit of several states from the scheme, citing high premium.

leave room for Covid response, macro risks'

MOODY'S INVESTORS SER-VICE on Friday said India's conservative Budget assumptions leave room for the government to respond to prevailing macroeconomic and pandemic risks over the next year. The government assumes that inflationadjusted real GDP growth for FY21 will come in at 9.2% in the current fiscal, following a growth of 13.6% in H1FY22.

Mirroring the government's conservative growth assumptions, the revised BEs for FY21 show revenue receipts growing only 27.2%, which leaves some scope for further gains once the fiscal accounts are tallied at the end of March 2022, Moody's said. It said the focus on capex in 2022-23 Budget supports near-term growth, but poses challenges to longer-term fiscal consolidation.

दिल्ली में कोरोना के मामलों में गिरावट लगातार जारी है। दिल्ली स्वास्थ्य विभाग ने शुक्रवार को जारी रिपोर्ट में बताया कि बीते दिन 2,272 नए मामले सामने आए और संक्रमण

दर 3.85 फीसद दर्ज की गई। वहीं इस दौरान 20 मरीजों की मौत हो गई। शुक्रवार को कुल 59,036 लोगों की जांच की गई। इसमें 47,449 आरटी-पीसीआर

जांच की गई। वहीं 11,257 रैपिड जांच की

कोरोना संक्रमण की लहर धीमी पडने के बाद राज्य सरकार ने दिल्लीवासियों को राहत दी है लेकिन सरकारी आंकडे बता रहे हैं कि इस लहर में सबसे अधिक नुकसान अन्य दुसरी बीमारी वाले मरीजों का उठाना पड़ा है। मात्र 22 दिन के अंदर दिल्ली में 691 मरीजों की मौत कोरोना संक्रमण की वजह से हुई है। संक्रमण से मरने वाले मरीजों में सबसे अधिक ऐसे मरीज शामिल हैं जो अस्पतालों में अपनी किसी अन्य बीमारी का इलाज करवाने के लिए पहुंचे थे।

सरकारी रिपोर्ट के मुताबिक ऐसे 531 मरीज जो संक्रमण का शिकार थे। उन्हें अपनी जान से हाथ धोना पडा है







स्कूल तो खुले, पर संक्रमण से बचाव के नियम होंगे सख्त

जनसत्ता संवाददाता नई दिल्ली, 4 फरवरी।

कोरोनाकाल में बच्चों के लिए पढ़ाई करने के नियम और भी सख्त होंगे। कक्षा में आने वाले बच्चे अपने किसी भी अन्य सहपाठी के साथ अपनी किताबें, कापी, स्टेशनरी और यहां तक की खाना एक दूसरे के साथ नहीं बांटेंगे। दिल्ली आपदा प्रबंधन प्राधिकरण (डीडीएमए) ने ताजा आदेशों में इस व्यवस्था का प्रावधान किया है। डीडीएमए ने इसके लिए एक फार्म बनवाया है जिसे अभिभावकों से भरवाना अनिवार्य होगा।

इन जरूरी प्रावधानों के अतिरिक्त केवल वे ही बच्चे स्कूल में आ सकेंगे, जिनके अभिभावक बच्चे को स्कूल भेजने के सहमति फार्म पर हस्ताक्षर करेंगे। डीडीएमए ने यह फार्म तैयार किया है और यह संबंधित स्कल प्रमुख के लिए होगा। इस फार्म में अभिभावकों की तरफ से बच्चों को स्कूल भेजने की सहमित के साथ यह भी सुनिश्चित किया गया है कि स्कूल में आने वाले बच्चे अपने साथ मास्क व सेनिटाइजर लेकर आएंगे। इसके अतिरिक्त अपने सहपाठियों के साथ कोरोना संक्रमण तय नियमों का सख्ती से पालन भी करेंगे।

अपने आदेशों में डीडीएमए ने स्कूलों के लिए भी 15 सख्त प्रावधान किए हैं। इन प्रावधानों की एक चेक लिस्ट तैयार की गई है। जिनमें हर दिन स्कूल की जांच होगी। इसके साबन, आदि की व्यवस्था, सभी कर्मचारी का कराने का प्रावधान किया गया है।

विद्यालय आने के लिए लेनी होगी अभिभावकों से सहमति

फैसले का प्रधानाध्यापकों ने किया स्वागत

नई दिल्ली, ४ फरवरी (भाषा)।

स्कूलों के प्रधानाध्यापकों ने राजधानी में लंबे समय तक बंद रहने के बाद स्कूलों को फिर से खोलने के फैसले का स्वागत किया और उम्मीद जताई कि आगे पठन-पाठन में कोई बाधा नहीं आएगी जबिक अभिभावकों का एक वर्ग जूनियर कक्षाओं के लिए स्कूल फिर से खुलने को लेकर संशय में है।

बता दें कि डीडीएमए ने शुक्रवार को आगामी सात फरवरी से कक्षा 9वीं से लेकर 12वीं तक के लिए और इसके साथ ही, 14 फरवरी से नर्सरी से 8वीं तक की कक्षाएं फिर से शुरू करने का भी निर्णय किया गया।

नेशनल प्रोग्रेशिव स्कूल कांफ्रेंस (एनपीएससी) की अध्यक्ष सुधा आचार्य ने कहा, 'कक्षा 9वीं से 12वीं के लिए सोमवार से और कक्षा नर्सरी से 8वीं तक के लिए 14 फरवरी से स्कूल खोलने की घोषणा से छात्र उत्साहित हैं। हम डीडीएमए के निर्णय का स्वागत करते हैं। स्कूल से जुड़े सभी हितधारक इसका बेसब्री से इंतजार कर रहे थे।'

नर्सरी कक्षाओं में दाखिले के लिए पहली सूची जारी

दिल्ली के स्कूलों ने नर्सरी कक्षाओं में दाखिले के लिए शुक्रवार को अपनी-अपनी प्रथम सूची जारी कर दी। स्कूलों ने पूर्व में अपने द्वारा घोषित 'प्वाइंट' आधारित अर्हता का इस्तेमाल करते हुए अपनी-अपनी प्रथम सूची जारी की।

शिक्षा निदेशालय के एक वरिष्ठ अधिकारी ने कहा, दाखिले के लिए चयनित बच्चों की प्रथम सूची शुक्रवार को जारी कर दी गई और दूसरी सूची 21 फरवरी को आएगी तथा जरूरत पड़ने पर 15 मार्च को तीसरी सूची जारी की जाएगी। संपूर्ण दाखिला प्रक्रिया 31 मार्च को संपन्न हो जाएगी।'

स्कूल की तरफ से सूची को आधिकारिक वेबसाइट पर अपलोड किया जाएगा। दाखिले के लिए बच्चे और माता-पिता पासपोर्ट साइज फोटो, परिवार की तस्वीर, निवास प्रमाण पत्र, बच्चे का जन्म प्रमाण पत्र और बच्चे का आधार कार्ड अनिवार्य होगा। जारी आदेश के अनुसार प्री-स्कूल (नर्सरी) , प्री-प्राइमरी (केजी) और कक्षा एक के दाखिले के लिए न्यूनतम आयु क्रमशः तीन, साल, चार साल व पांच साल निर्धारित की गई है।

दिल्ली में 1,800 से अधिक स्कूलों में नर्सरी कक्षाओं में दाखिले की प्रक्रिया पिछले साल 15 दिसंबर को शुरू हुई थी। जानकारी के अनुसार नर्सरी स्कूल में सामान्य वर्ग की 75 फीसद सीटों पर दाखिले होंगे। शेष 25 फीसद वर्गों के लिए निर्धारित हैं।
